- 18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 19 That the Laws of Maryland read as follows:

- not an enemy, may own, sell, devise, dispose of, or otherwise deal with property in the same
 manner as if he had been a citizen of the State by birth.

- 9 (3) "FOREIGN COUNTRY" MEANS A COUNTRY, INCLUDING A 10 POLITICAL SUBDIVISION OF THE COUNTRY, OTHER THAN THE UNITED STATES AND 11 THE TERRITORIES AND POSSESSIONS OF THE UNITED STATES.

- 4 2. IN WHICH, AS DETERMINED BY REGULATIONS OF THE
- 5 United States Department of Agriculture adopted under the federal
- 6 AGRICULTURAL FOREIGN INVESTMENT DISCLOSURE ACT OF 1978, A SIGNIFICANT
- 7 INTEREST OR SUBSTANTIAL CONTROL IS DIRECTLY OR INDIRECTLY HELD BY:
- 8 A. AN INDIVIDUAL DESCRIBED IN ITEM (I) OF THIS
- 9 PARAGRAPH;
- B. A PERSON DESCRIBED IN ITEM (III) OF THIS
- 11 PARAGRAPH; OR
- 12 C. A FOREIGN GOVERNMENT.
- 13 (B) THIS SECTION DOES NOT APPLY TO:
- 14 (1) A SECURITY INTEREST;
- 15 (2) A LEASEHOLD OF LESS THAN 10 YEARS;
- 16 (3) A CONTINGENT FUTURE INTEREST;
- 17 (4) A NONCONTINGENT FUTURE INTEREST THAT DOES NOT BECOME
- 18 POSSESSORY ON THE TERMINATION OF THE PRESENT POSSESSORY ESTATE;
- 19 (5) A SURFACE OR SUBSURFACE EASEMENT OR RIGHT-OF-WAY USED
- 20 FOR A PURPOSE UNRELATED TO AGRICULTURAL PRODUCTION;
- 21 (6) AN INTEREST SOLELY IN MINERAL RIGHTS; OR
- 22 (7) AN INTEREST IN AGRICULTURAL LAND ACQUIRED BY A FOREIGN
- 23 PERSON ON OR BEFORE SEPTEMBER 30, 2023.
- 24 (C) (1) ON OR AFTER OCTOBER 1, 2023, A FOREIGN PERSON MAY NOT
- 25 PURCHASE, LEASE, OR OTHERWISE ACQUIRE ANY INTEREST IN AGRICULTURAL

- 27 (2) THE TRANSFER OF AN INTEREST IN AGRICULTURAL LAND TO A

- 1 (D) THIS SECTION MAY NOT BE APPLIED IN A MANNER INCONSISTENT WITH
- 2 THE PROVISIONS OF ANY TREATY BETWEEN THE UNITED STATES AND ANOTHER
- 3 COUNTRY.
