1 (2) The terms of commissioners are staggered as required by the terms 2 provided for commissioners on July 1, 1982.

3 (3) At the end of a term, a commissioner continues to serve until a successor 4 is appointed and takes the oath of office.

5 (4) A commissioner who is appointed after a term has begun serves only for 6 the rest of the term and until a successor is appointed and takes the oath of office.

7 (5) A vacancy on the Commission does not impair the right of the 8 remaining commissioners to exercise all the powers of the Commission.

### 9 (E) THE GENERAL MANAGER OF THE COMMISSION HAS THE SAME VOTING 10 POWERS AS THE COMMISSIONERS ON ALL MATTERS BEFORE THE COMMISSION 11 EXCEPT REGARDING DECISIONS RELATING TO:
