A BILL ENTITLED

1 AN ACT concerning

2 **Public Schools – Student Telehealth Appointments – Policy and Access**

3 FOR the purpose of requiring each county board of education to establish a policy to
4 accommodate students who need to participate in telehealth appointments during
5 the school day; requiring each public middle and high school to designate a space
6 that meets certain requirements for student telehealth appointments; and generally
7 relating to student access to telehealth in schools.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **4–142.**

17 **(A) IN THIS SECTION, “TELEHEALTH” MEANS A MODE OF DELIVERING**
18 **HEALTH CARE SERVICES THROUGH THE USE OF TELECOMMUNICATIONS**
19 **TECHNOLOGIES BY A HEALTH CARE PRACTITIONER TO A PATIENT AT A DIFFERENT**
20 **PHYSICAL LOCATION THAN THE HEALTH CARE PRACTITIONER.**

21 **(B) EACH COUNTY BOARD SHALL ESTABLISH A POLICY TO ACCOMMODATE**
22 **STUDENTS WHO NEED TO PARTICIPATE IN TELEHEALTH APPOINTMENTS**
23 **SCHEDULED DURING THE SCHOOL DAY.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(C) THE POLICY ESTABLISHED UNDER SUBSECTION (B) OF THIS SECTION**
2 **SHALL REQUIRE EACH MIDDLE AND HIGH SCHOOL TO DESIGNATE A SPACE FOR**
3 **STUDENT TELEHEALTH APPOINTMENTS THAT:**

4 **(1) IS A PRIVATE SPACE IN THE SCHOOL;**

5 **(2) HAS INTERNET ACCESS;**

6 **(3) INCLUDES AT LEAST ONE SEATING OPTION WITH A FLAT SURFACE**
7 **AND ELECTRICAL OUTLET NEARBY TO ACCOMMODATE PLACEMENT OF A LAPTOP**
8 **DEVICE; AND**

9 **(4) IS NOT A BATHROOM OR CLOSET.**

10 **(D) EACH COUNTY BOARD SHALL ENSURE THAT THE LOCAL SCHOOL**
11 **SYSTEM:**

12 **(1) PUBLISHES THE STUDENT TELEHEALTH POLICY IN THE STUDENT**
13 **HANDBOOK; AND**

14 **(2) PROVIDES TRAINING FOR SCHOOL PERSONNEL ON STUDENT**
15 **TELEHEALTH POLICY OBJECTIVES AND REQUIREMENTS.**

16 **(E) ON REQUEST, THE DEPARTMENT SHALL PROVIDE TECHNICAL**
17 **ASSISTANCE TO A COUNTY BOARD TO ESTABLISH THE STUDENT TELEHEALTH**
18 **POLICY REQUIRED UNDER THIS SECTION.**

19 **(F) NOTHING IN THIS SECTION SHALL BE CONSTRUED TO REQUIRE A**
20 **SCHOOL TO CONSTRUCT AN ADDITION OR NEW SPACE TO A SCHOOL BUILDING TO**
21 **PROVIDE A PRIVATE SPACE TO COMPLY WITH THE STUDENT TELEHEALTH POLICY**
22 **REQUIRED UNDER THIS SECTION.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2023.
