Garrett County Alcoholic Beverages Act of 2023

- 3 FOR the purpose of altering a certain condition under which the Board of License 4 Commissioners of Garrett County may issue a certain alcoholic beverages license to $\mathbf{5}$ a hotel or motel: authorizing a gift basket permit holder to purchase certain alcoholic 6 beverages from a wholesaler; authorizing a holder of a Class C multiple day beer 7 license, beer and wine license, or beer, wine, and liquor license to hold another license 8 that is issued by the Board; authorizing a holder of a multiple event license to hold 9 another license that is issued by the Board; altering the hours of sale for alcoholic 10 beverages on Sunday for certain licenses; establishing the framework for the 11 expiration of alcoholic beverages licenses in the county; and generally relating to 12 alcoholic beverages in Garrett County.

 4 MAY NOT BE SUSPENDED ON THE BASIS OF THE WITHDRAWN APPLICATION OR
 5 REQUEST; AND

6 (II) THE APPLICATION OR REQUEST SHALL BE CONSIDERED AS 7 IF IT HAD NOT BEEN FILED.

8 (D) IF A LICENSED PREMISES IS FORCED TO CLOSE BECAUSE OF A 9 CASUALTY LOSS, THE BOARD, WITHOUT CIRCUIT COURT APPROVAL, MAY EXTEND 10 THE LICENSE FOR NOT MORE THAN 2 YEARS AFTER THE CLOSING.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2023.
