2 Motor Vehicles - Off-the-Road Motorcycles - Local Regulation and Enforcement

- FOR the purpose of authorizing a municipal corporation to regulate the operation of and register off—the—road motorcycles; authorizing a county or municipal corporation to enforce the Maryland Vehicle Law for violations involving off—the—road motorcycles and to enact and implement legislation governing impoundment, release from impoundment, and, if lawful, forfeiture; and generally relating to local regulation and enforcement related to off—the—road motorcycles.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 18 (a) (1) In this section, "off-the-road motorcycle" means a [motorcycle not]
- 19 MOTOR VEHICLE THAT:
- 20 (I) EXCEPT AS PROVIDED IN PARAGRAPH (2)(II) OF THIS
- 21 SUBSECTION, HAS TWO OR THREE WHEELS; AND
- 22 (II) Is not otherwise registered OR ELIGIBLE FOR REGISTRATION
