A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Sunday Sales**

3 FOR the purpose of altering the hours during which a licensee may sell alcoholic beverages
4 on Sundays in Frederick County; and generally relating to alcoholic beverages in
5 Frederick County.

6 BY repealing and reenacting, without amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

20 20–102.

21 This title applies only in Frederick County.

22 20–1004.

23 (a) There is a Class B–CC (conference center) beer, wine, and liquor license.

1 (d) The license holder may sell beer, wine, and liquor[:

2 (1)] on Monday through [Saturday] **SUNDAY**, from 6 a.m. to 2 a.m. the
3 following day[: and

4 (2) on Sunday, from 11 a.m. to 2 a.m. the following day].

5 20–1007.

6 (a) There is a Class B–DT (dinner theater) beer, wine, and liquor license.

7 (d) A license holder may sell beer, wine, and liquor beginning 2 hours before a live
8 performance until the end of the performance[:

9 (1)] on Monday through [Saturday; and

10 (2) on or after 1 p.m. on] Sunday.

11 20–1009.

12 (a) There is a Class EC (entertainment center) license.

13 (e) The [hours of sale are:

14 (1) on Monday through Saturday, from 6 a.m. to 2 a.m. the following day;
15 and

16 (2) on Sunday, from 11 a.m. to 2 a.m. the following day] **LICENSE HOLDER**
17 **MAY SELL BEER, WINE, AND LIQUOR DURING THE HOURS AND DAYS AS SET OUT FOR**
18 **A CLASS B BEER, WINE, AND LIQUOR LICENSE UNDER § 20–2005 OF THIS TITLE.**

19 20–1009.1.

20 (a) There is a hotel lobby license.

21 (e) The license holder may sell beer and wine[:

22 (1) on Monday through Saturday, from 6 a.m. to 2 a.m. the following day;
23 and

24 (2) on Sunday, from 11 a.m. to 2 a.m. the following day] **DURING THE**
25 **HOURS AND DAYS AS SET OUT FOR A CLASS B BEER AND WINE LICENSE UNDER §**
26 **20–2004 OF THIS TITLE.**

27 20–1009.2.

1 (a) This section applies only to a municipal golf course that is operated by a
 2 municipal golf course manager or a golf course manager under a management agreement
 3 with the City of Frederick.

4 (g) The [hours of sale are:

5 (1) on Monday through Saturday, from 6 a.m. to 10 p.m.; and

6 (2) on Sunday, from 10 a.m. to 10 p.m.] **LICENSE HOLDER MAY SELL**
 7 **BEER, WINE, AND LIQUOR DURING THE HOURS AND DAYS AS SET OUT FOR A CLASS**
 8 **B BEER, WINE, AND LIQUOR LICENSE UNDER § 20-2005 OF THIS TITLE.**

9 20-2002.

10 (a) (1) A holder of a Class A beer license may sell beer[:

11 (i)] on Monday through Saturday, from 6 a.m. to 2 a.m. the following
 12 day[: and

13 (ii) on Sunday, from 10 a.m. to 2 a.m. the following day].

14 (2) (i) The Board may grant a special Sunday opening permit to the
 15 license holder.

16 (ii) The permit authorizes the holder to sell beer for off-premises
 17 consumption on Sunday from [10 a.m.] **6 A.M.** to 2 a.m. the following day.

18 (iii) The annual permit fee is \$100 in addition to the annual fee for
 19 the license.

20 (iv) The permit is not considered a separate class of license and, if it
 21 is granted, the privilege shall be incorporated into the license.

22 (b) [(1)] A holder of a Class B beer license may sell beer[:

23 (i)] on Monday through [Saturday] **SUNDAY**, for on- and
 24 off-premises consumption, from 6 a.m. to 2 a.m. the following day[: and

25 (ii) on Sunday:

26 1. subject to paragraph (2) of this subsection, for
 27 on-premises consumption:

28 A. from 10 a.m. to 2 a.m. the following day; or

1 B. for a specific event that the Board has approved, the hours
2 for the event that are set by the Board; and

3 2. for off-premises consumption, from 1 p.m. to 2 a.m. the
4 following day.

5 (2) The license holder may not sell beer at a bar or counter on Sunday].

6 (c) A holder of a Class C beer (on-sale) license may sell beer:

7 (1) on Monday through [Saturday] **SUNDAY**, from 6 a.m. to 2 a.m. the
8 following day; and

9 (2) [on Sunday:

10 (i) from 10 a.m. to 2 a.m. the following day; or

11 (ii)] for a specific event that the Board has approved, the hours for
12 the event that are set by the Board.

13 20-2004.

14 (a) (1) A holder of a Class A beer and wine license may sell beer and wine[:

15 (i)] on Monday through Saturday, from 6 a.m. to 2 a.m. the following
16 day[: and

17 (ii) on Sunday, from 10 a.m. to 2 a.m. the following day].

18 (2) (i) The Board may grant a special Sunday opening permit to the
19 license holder.

20 (ii) The permit authorizes the holder to sell beer for off-premises
21 consumption on Sunday from [10 a.m.] **6 A.M.** to 2 a.m. the following day.

22 (iii) The annual permit fee is \$140 in addition to the annual fee for
23 the license.

24 (iv) The permit is not considered a separate class of license and, if it
25 is granted, the privilege shall be incorporated into the license.

26 (b) [(1)] A holder of a Class B beer and wine license may sell beer and wine[:

27 (i)] on Monday through [Saturday] **SUNDAY**, for on- and
28 off-premises consumption, from 6 a.m. to 2 a.m. the following day[: and

1 (ii) on Sunday:

2 1. subject to paragraph (2) of this subsection, for
3 on-premises consumption:

4 A. from 10 a.m. to 2 a.m. the following day; or

5 B. for a specific event that the Board has approved, the hours
6 for the event that are set by the Board; and

7 2. for off-premises consumption, from 1 p.m. to 2 a.m. the
8 following day.

9 (2) The license holder may not sell beer or wine at a bar or counter on
10 Sunday].

11 (c) A holder of a Class C beer and wine license may sell beer and wine[:

12 (1)] on Monday through [Saturday] **SUNDAY**, for on-premises
13 consumption, from 6 a.m. to 2 a.m. the following day]; and

14 (2) on Sunday, for on-premises consumption:

15 (i) from 10 a.m. to 2 a.m. the following day; or

16 (ii) for a specific event that the Board has approved, the hours for
17 the event that are set by the Board].

18 20-2005.

19 (a) (1) A holder of a Class A beer, wine, and liquor license may sell beer, wine,
20 and liquor on Monday through Saturday, from 6 a.m. to 2 a.m. the following day.

21 (2) (i) The Board may grant a special Sunday opening permit to the
22 license holder.

23 (ii) The permit authorizes the holder to sell beer, wine, and liquor
24 for off-premises consumption on Sunday from [10 a.m.] **6 A.M.** to 2 a.m. the following day.

25 (iii) The annual permit fee is \$650 in addition to the annual fee for
26 the license.

27 (iv) The permit is not considered a separate class of license and, if it
28 is granted, the privilege shall be incorporated into the license.

1 (b) [(1)] A holder of a Class B beer, wine, and liquor license may sell beer, wine,
2 and liquor:

3 [(i)] (1) on Monday through Saturday, for on- and off-premises
4 consumption, from 6 a.m. to 2 a.m. the following day; and

5 [(ii)] (2) on Sunday:

6 [1.] (I) [subject to paragraph (2) of this subsection,] for
7 on-premises consumption:

8 [A.] 1. from [10 a.m.] **6 A.M.** to 2 a.m. the following day; or

9 [B.] 2. for a specific event that the Board has approved, the
10 hours for the event that are set by the Board; and

11 [2.] (II) for off-premises consumption, from 1 p.m. to 2 a.m.
12 the following day.

13 [(2)] The license holder may not sell beer, wine, or liquor at a bar or counter
14 on Sunday.]

15 (c) A holder of a Class B beer, wine, and liquor license in the Ballenger (23rd)
16 election district may sell beer, wine, and liquor[:

17 (1)] on Monday through [Saturday] **SUNDAY**, from 6 a.m. to 2 a.m. the
18 following day[: and

19 (2) on Sunday, from 10 a.m. to 2 a.m. the following day].

20 (d) A holder of a Class C beer, wine, and liquor license may sell beer, wine, and
21 liquor for on- and off-premises consumption[:

22 (1)] on Monday through [Saturday] **SUNDAY**, from 6 a.m. to 2 a.m. the
23 following day[: and

24 (2) on Sunday:

25 (i) from 10 a.m. to 2 a.m. the following day; or

26 (ii) for a specific event that the Board has approved, the hours for
27 the event that are set by the Board].

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
29 1, 2023.
