1 AN ACT concerning

2 **Poplar Island and Mid-Chesapeake Bay Island Citizens Oversight Committee –**
3 **Establishment**

4 FOR the purpose of establishing the Poplar Island and Mid-Chesapeake Bay Island
5 Citizens Oversight Committee to monitor certain activities and hear and address
6 certain concerns and complaints relating to Poplar Island, Mid-Chesapeake Bay
7 Island, the Paul S. Sarbanes Ecosystem Restoration Project at Poplar Island, and
8 the Mid-Chesapeake Bay Island Ecosystem Restoration Project; and generally
9 relating to the Poplar Island and Mid-Chesapeake Bay Island Citizens Oversight
10 Committee.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Environment**

19 **5–1104.3.**

20 **(A) THERE IS A POPLAR ISLAND AND MID-CHESAPEAKE BAY ISLAND**
21 **CITIZENS OVERSIGHT COMMITTEE.**

22 **(B) (1) THE OVERSIGHT COMMITTEE SHALL CONSIST OF THE**
23 **FOLLOWING MEMBERS, APPOINTED BY THE GOVERNOR:**

2 HERITAGE ASSOCIATION;

3 (II) ONE MEMBER REPRESENTING THE TALBOT WATERMEN
4 ASSOCIATION;

5 (III) ONE MEMBER REPRESENTING THE DORCHESTER COUNTY
6 SHORE EROSION CONTROL DISTRICT IN WHICH MID-CHESAPEAKE BAY ISLAND IS
7 LOCATED;

8 (IV) ONE MEMBER REPRESENTING TALBOT COUNTY;

9 (V) ONE MEMBER REPRESENTING DORCHESTER COUNTY;

10 (VI) TWO MEMBERS REPRESENTING SPORT FISHING;

11 (VII) ONE MEMBER REPRESENTING THE PLEASURE BOATING
12 INDUSTRY;

13 (VIII) TWO MEMBERS REPRESENTING THE BIRDING COMMUNITY;

14 (IX) ONE MEMBER REPRESENTING THE EASTERN SHORE LAND
15 CONSERVANCY; AND

16 (X) TWO MEMBERS REPRESENTING LEGISLATIVE DISTRICTS
17 37A AND 37B.

18 (2) THE GOVERNOR SHALL DETERMINE THE TERMS AND
19 QUALIFICATIONS OF THE MEMBERS OF THE OVERSIGHT COMMITTEE.

20 (C) THE OVERSIGHT COMMITTEE SHALL:

21 (1) MONITOR THE CONSTRUCTION OF CONTAINMENT STRUCTURES,
22 PLACEMENT OF DREDGE MATERIALS, HABITAT RESTORATION AND MAINTENANCE
23 ACTIVITIES, PUBLIC OUTREACH PROGRAMS, AND HABITAT AND WILDLIFE
24 ASSESSMENT ACTIVITIES ON AND AROUND POPLAR ISLAND AND MID-CHESAPEAKE
25 BAY ISLAND;

26 (2) HEAR AND ADDRESS CONCERNS OR COMPLAINTS FROM
27 INDIVIDUALS AFFECTED BY THE CONSTRUCTION AND SPOIL PLACEMENT
28 ACTIVITIES ASSOCIATED WITH THE PAUL S. SARBANES ECOSYSTEM RESTORATION
29 PROJECT AT POPLAR ISLAND AND THE MID-CHESAPEAKE BAY ISLAND
30 ECOSYSTEM RESTORATION PROJECT; AND

1 **(3) MONITOR THE DEVELOPMENT OF LONG-TERM PUBLIC ACCESS**
2 **PLANS FOR POPLAR ISLAND AND MID-CHESAPEAKE BAY ISLAND AND THE**
3 **SURROUNDING AREAS.**

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2023.
