1 AN ACT concerning

2 **Public Employee Relations Act**

3 FOR the purpose of consolidating and altering certain laws governing collective bargaining
4 for certain public employees, including laws related to the establishment of
5 bargaining units, elections and certification of exclusive representatives, employee
6 and employer rights, unfair labor practices, and strikes and lockouts; establishing
7 the Public Employee Relations Board to oversee collective bargaining activities for
8 certain public employees; repealing the State Labor Relations Board, the State
9 Higher Education Labor Relations Board, and the Public School Labor Relations
10 Board; establishing that certain grievance procedures for State employees serve as
11 a certain procedure for certain disputes between certain parties; ~~requiring the Office~~
12 ~~of Administrative Hearings to resolve certain disputes regarding a certain~~
13 ~~memorandum of understanding or written agreement under certain circumstances;~~
14 and generally relating to collective bargaining for public employees.

2 (e) (4) (i) The Public [School Labor] **EMPLOYEE** Relations Board shall
3 decide any controversy or dispute arising under Title 6, Subtitle 4 or Subtitle 5 of this
4 article.

5 (ii) A decision of the Public [School Labor] **EMPLOYEE** Relations
6 Board is final.

7 6–401.

8 (a) In this subtitle the following words have the meanings indicated.

9 (b) “Board” means the Public [School Labor] **EMPLOYEE** Relations Board
10 [established under Subtitle 8 of this title].

11 (b–1) “Day” means a calendar day unless otherwise indicated.

12 (c) “Employee organization” [means an organization that:

13 (1) Includes certificated employees of a public school employer or
14 individuals of equivalent status in Baltimore City; and

15 (2) Has as one of its main purposes the representation of the employees in
16 their relations with that public school employer] **HAS THE MEANING STATED IN § 21–101**
17 **OF THE STATE GOVERNMENT ARTICLE.**

18 (d) (1) “Home and hospital teacher” means a teacher employed by a public
19 school employer to provide instructional services to a public school student who is unable
20 to function effectively in the classroom setting due to the student’s medical, physical, or
21 emotional condition.

22 (2) A home and hospital teacher may teach in:

23 (i) A private home;

24 (ii) A hospital;

25 (iii) A therapeutic center;

26 (iv) A school; or

27 (v) Any other appropriate site.

1 (d-1) “New employee processing” means the process for a newly hired public school
2 employee, whether in person, online, or through other means, in which new employees are
3 advised of their employment status, rights, benefits, duties, responsibilities, and other
4 employment-related matters.

5 (e) (1) “Public school employee” means a certificated professional individual
6 who is employed by a public school employer or an individual of equivalent status in
7 Baltimore City, except for a county superintendent or an individual designated by the
8 public school employer to act in a negotiating capacity as provided in § 6-408(c) of this
9 subtitle.

10 (2) In Montgomery County, “public school employees” include:

11 (i) Certificated and noncertificated substitute teachers employed by
12 the public school employer for at least 7 days before March 1 of the school fiscal year ending
13 June 30, 1978, and each year after; and

14 (ii) Home and hospital teachers employed by the public school
15 employer for at least 7 days before March 1 of the school fiscal year ending June 30, 2000,
16 and each year after.

17 (3) In Baltimore County, “public school employee” includes a secondary
18 school nurse, an elementary school nurse, and a special school nurse.

19 (4) In Frederick County, “public school employee” includes a social worker
20 employed by a public school employer.

21 (5) In Prince George’s County, “public school employee” includes home and
22 hospital teachers and Junior Reserve Officer Training Corps (JROTC) instructors.

23 (6) In Baltimore County, Calvert County, Charles County, and Garrett
24 County, “public school employee” includes Junior Reserve Officer Training Corps (JROTC)
25 instructors.

26 (7) In Carroll County, “public school employee” includes:

27 (i) A registered nurse;

28 (ii) Supervisory noncertificated employees as defined under §
29 6-501(i) of this title; and

30 (iii) Junior Reserve Officer Training Corps (JROTC) instructors.

31 (f) “Public school employer” means a county board of education or the Baltimore
32 City Board of School Commissioners.

33 6-402.

1 (a) Public school employees may form, join, and participate in the activities of
2 employee organizations of their own choice for the purpose of being represented on all
3 matters that relate to salaries, wages, hours, and other working conditions.

4 [(b) An employee organization may establish reasonable:

5 (1) Restrictions as to who may join; and

6 (2) Provisions for the dismissal of individuals from membership.]

7 **(B) PUBLIC SCHOOL EMPLOYEES, PUBLIC SCHOOL EMPLOYERS, AND**
8 **EXCLUSIVE REPRESENTATIVES ARE SUBJECT TO THE PROVISIONS OF TITLE 21 OF**
9 **THE STATE GOVERNMENT ARTICLE.**

11 (a) [Each public school employer shall designate, as provided in this subtitle,
12 which employee organization, if any, shall be the exclusive representative of all public
13 school employees in a specified unit in the county.

14 (b) (1) Except as provided in paragraph (2) of this subsection, the public school
15 employer shall determine the composition of the unit in negotiation with any employee
16 organization that requests negotiation concerning the composition of the unit.

17 (2) In St. Mary's County, licensed registered school nurses, Junior Reserve
18 Officers' Training Corps (JROTC) teachers, and supervisory noncertificated employees of
19 the public school employer shall be included in the unit.

20 [(c) (B) (1) There may not be more than two units in a county.

21 (2) In Baltimore County, one of the units shall consist of employees who
22 are administrative and supervisory certificated employees. The second unit shall consist of
23 all other public school employees as defined under § 6-401(e)(1) and (3) of this subtitle.

24 [(d) (C) All eligible public school employees shall:

25 (1) Be included in one of these units; and

26 (2) Have the rights granted in this subtitle **AND TITLE 21 OF THE STATE**
27 **GOVERNMENT ARTICLE.**

28 6-404.

29 (a) [The designation of an employee organization as an exclusive representative
30 shall be made as provided in this section.

1 (b) If an employee organization certifies to the public school employer that it has
2 a membership enrollment of at least 30 percent of the total number of public school
3 employees in a specified unit in a county as of June 1 of the year in which certification is
4 made, this certification is a request for recognition as exclusive representative of all public
5 school employees in the specified unit in the county.

6 (c) If another employee organization certifies that it has a membership
7 enrollment of at least 10 percent of the total number of public school employees in the unit
8 as of the same June 1, an election shall be held in which the public school employees in the
9 unit shall be offered the opportunity to choose:

10 (1) One of the employee organizations as the exclusive representative of all
11 public school employees in the unit; or

12 (2) Not to have exclusive representation.

13 (d) If no other employee organization certifies that it has a membership
14 enrollment of at least 10 percent of the total number of public school employees in the unit,
15 on the request of the employee organization under subsection (b) of this section, an election
16 shall be held and the ballot shall offer a choice between:

17 (1) Exclusive representation by the organization; and

18 (2) Not to have exclusive representation.

19 (e) The public school employer shall designate the employee organization
20 described in subsection (b) of this section as the exclusive representative of all public school
21 employees in the specified unit in a county if:

22 (1) No other employee organization certifies that it has a membership
23 enrollment of at least 10 percent of the total number of public school employees in the unit;

24 (2) The employee organization does not request an election under
25 subsection (d) of this section; and

26 (3) The employee organization certifies that it has a membership
27 enrollment of the majority of the public school employees in the unit in the county.

28 (f) (1) The Board shall adopt rules and regulations for:

29 (i) Verifying the number of certificated employees of the public
30 school employer or individuals of equivalent status in Baltimore City who are members in
31 good standing of an employee organization on the date of the certification or who have
32 signed a petition under this section; and

1 (ii) Holding elections under this section and the certification of their
2 results.

3 (2) The Board shall provide for supervision of these elections.

4 (3) The elections] **AN ELECTION HELD UNDER TITLE 21, SUBTITLE 4**
5 **OF THE STATE GOVERNMENT ARTICLE** shall be held:

6 [(i)] (1) In each school facility where public employees are
7 assigned on a regularly scheduled school day;

10 between June 1 and June 15, inclusive, except in Baltimore City where the elections shall
11 be held between November 1 and November 15 following the date on which certification of

13 [(4) In any election held under this section, the employee organization that
14 receives the largest number of votes cast in a unit shall be declared to be the exclusive
15 representative of all public school employees in the unit. If the largest number of votes in
16 the election is cast not to have exclusive representation, a representative may not be
17 designated for the unit.

18 [(5)] (B) The public school employer shall provide any assistance required
19 in holding the elections.

20 6-405.

21 (a) (1) (i) Each public school employer shall provide the exclusive
22 representative access to new employee processing.

23 (ii) Except as provided in subparagraph (iii) of this paragraph, the
24 public school employer shall provide the exclusive representative at least 10 days' notice in
25 advance of a new employee processing.

26 (iii) The public school employer may provide the exclusive
27 representative with less than 10 days' notice if there is an urgent need critical to the public
28 school employer's new employee processing that was not reasonably foreseeable.

29 (2) (i) The structure, time, and manner of the access required in
30 paragraph (1) of this subsection shall be determined through negotiations between the
31 public school employer and the exclusive representative in accordance with [§ 6-408] §
32 6-406 of this subtitle.

1 (ii) When negotiating access to new employee processing under
2 subparagraph (i) of this paragraph, if any dispute has not been resolved within 45 days
3 after the first meeting of the public school employer and the exclusive representative, or
4 within 60 days after an initial request to negotiate, whichever occurs first, either party may
5 request that the Board declare an impasse under [§ 6-408(e)] § 6-406(E) of this subtitle.

6 (iii) In an impasse proceeding under [§ 6-408(e)] § 6-406(E) of this
7 subtitle, the mediator or Board shall consider:

8 1. The ability of the exclusive representative to communicate
9 with the public school employees it represents;

10 2. The legal obligations of the exclusive representative to the
11 public school employees;

12 3. Applicable State, federal, and local laws;

13 4. Any stipulations of the parties;

14 5. The interests and welfare of the public school employees
15 and the financial condition of the public school employer;

16 6. The structure, time, and manner of access of an exclusive
17 representative to new employee processing in comparable public school employers,
18 including the access provisions in other memoranda of understanding or collective
19 bargaining agreements; and

20 7. Any other facts routinely considered in establishing the
21 structure, time, and manner of access of an exclusive representative to new employee
22 processing.

23 (3) (i) A request to negotiate under paragraph (2) of this subsection
24 made between July 1, 2018, and the expiration date of an existing collective bargaining
25 agreement between the parties shall reopen the existing collective bargaining agreement
26 only for the purpose of negotiating the access of the exclusive representative to the public
27 school employer's new employee processing.

28 (ii) Either party may elect to negotiate a separate agreement on the
29 access of the exclusive representative to the public school employer's new employee
30 processing in lieu of reopening the existing collective bargaining agreement.

31 (b) This section does not prohibit a public school employer and an exclusive
32 representative from negotiating access to new employee processing that varies from the
33 requirements of this section.

34 (c) Nothing in this section shall abrogate existing collective bargaining
35 agreements between public school employers and exclusive representatives.

6 (a) In this subtitle the following words have the meanings indicated.

7 (b) “Board” means the Public [School Labor] **EMPLOYEE** Relations Board
8 [established under Subtitle 8 of this title].

9 (c) “Confidential employee” includes an individual whose employment
10 responsibilities require knowledge of the public school employer’s posture in the collective
11 negotiation process, as determined by the public school employer in negotiations with an
12 employee organization that requests negotiation on this issue.

13 (c-1) “Day” means a calendar day unless otherwise indicated.

14 (d) “Employee organization” [means an organization that:

15 (1) Includes noncertificated employees of a public school employer; and

16 (2) Has as one of its main purposes the representation of the employees in
17 their relations with that public school employer] **HAS THE MEANING STATED IN § 21-101**
18 **OF THE STATE GOVERNMENT ARTICLE.**

19 (e) [“Management personnel”] **“MANAGERIAL EMPLOYEE”** includes an
20 individual who is engaged mainly in executive and managerial functions.

21 (e-1) “New employee processing” means the process for a newly hired public school
22 employee, whether in person, online, or through other means, in which new employees are
23 advised of their employment status, rights, benefits, duties, responsibilities, and other
24 employment-related matters.

25 (f) “Noncertificated employee”, in Montgomery County, means only a full-time
26 employee.

27 (g) (1) “Public school employee” means a noncertificated individual who is
28 employed for at least 9 months a year on a full-time basis by a public school employer.

29 (2) “Public school employee” includes a noncertificated employee in
30 Baltimore City notwithstanding that the noncertificated employee does not work for at
31 least 9 months a year on a full-time basis.

1 (3) “Public school employee” does not include:

2 (i) [Management personnel] **A MANAGERIAL EMPLOYEE; OR**

3 (ii) A confidential employee[]; or

4 (iii) Any individual designated by the public school employer to act in
5 a negotiating capacity as provided in § 6–510(c) of this subtitle].

6 (h) (1) “Public school employer” means the county board in each county.

7 (2) “Public school employer” includes the Baltimore City Board of School
8 Commissioners.

9 (i) “Supervisory employee” includes any individual who responsibly directs the
10 work of other employees.

11 6–503.

12 (a) Public school employees may form, join, and participate in the activities of
13 employee organizations of their own choice for the purpose of being represented on all
14 matters that relate to salaries, wages, hours, and other working conditions.

15 [(b) An employee organization may establish reasonable restrictions as to who
16 may join and reasonable provisions for the dismissal of individuals from membership,
17 except that these restrictions and provisions may not discriminate with regard to the terms
18 or conditions of membership because of race, color, marital status, creed, sex, age, or
19 national origin.]

24 (a) [(1) Each public school employer may designate, as provided in this subtitle,
25 which employee organization, if any, shall be the exclusive representative of all public
26 school employees in a specified unit in the county.

27 (2) In Baltimore City, Garrett County, and Frederick County, the public
28 school employer shall designate, as provided in this subtitle, which employee organization,
29 if any, shall be the exclusive representative of all public school employees in a specified unit
30 in the county.

1 (b) The public school employer shall determine the composition of the unit in
2 negotiation with any employee organization that requests negotiation concerning the
3 composition of the unit.

4 (c) (1) Except as provided in paragraphs (3) and (5) of this subsection, there
5 may not be more than three units in a county and a unit may not include both supervisory
6 and nonsupervisory employees.

7 (2) If a county has more than three recognized units and, as of July 1, 1974,
8 the units have exclusive representation for collective negotiations, these units may
9 continue as negotiating units.

10 (3) In Baltimore County, there shall be three units, including one unit of
11 supervisory employees as defined in § 6–501(i) of this subtitle.

12 (4) In Carroll County, beginning on October 1, 2007:

13 (i) There shall be no more than three units; and

14 (ii) All units shall be nonsupervisory units.

15 (5) In Baltimore City, the public school employer may designate a fourth
16 unit composed of all Baltimore City school police officers, as defined in § 4–318 of this
17 article, up to and including the rank of lieutenant.

18 [(d) (1) (B) All eligible public school employees shall:

19 [(i) (1) Be included in one of these units; and

20 [(ii) (2) Have the rights granted in this subtitle.

25 (a) Employee organizations recognized by the public school employer as the
26 exclusive representative of all public school employees in a specified unit on July 1, 1978
27 shall continue to be the exclusive representative[:

28 (1) For the rest of the 2–year initial period as provided by § 6–507 of this

8 (a) (1) (i) Each public school employer shall provide the exclusive
9 representative access to new employee processing.

10 (ii) Except as provided in subparagraph (iii) of this paragraph, the
11 public school employer shall provide the exclusive representative at least 10 days' notice in
12 advance of a new employee processing.

13 (iii) The public school employer may provide the exclusive
14 representative with less than 10 days' notice if there is an urgent need critical to the public
15 school employer's new employee processing that was not reasonably foreseeable.

16 (2) (i) The structure, time, and manner of the access required in
17 paragraph (1) of this subsection shall be determined through negotiations between the
18 public school employer and the exclusive representative in accordance with [§ 6-510] §
19 6-507 of this subtitle.

20 (ii) When negotiating access to new employee processing under
21 subparagraph (i) of this paragraph, if any dispute has not been resolved within 45 days
22 after the first meeting of the public school employer and the exclusive representative, or
23 within 60 days after an initial request to negotiate, whichever occurs first, either party may
24 request that the Board declare an impasse under [§ 6-510(e)] § 6-507(E) of this subtitle.

25 (iii) In an impasse proceeding under [§ 6-510(e)] § 6-507(E) of this
26 subtitle, the mediator or Board shall consider:

27 1. The ability of the exclusive representative to communicate
28 with the public school employees it represents;

29 2. The legal obligations of the exclusive representative to the
30 public school employees;

31 3. Applicable State, federal, and local laws;

32 4. Any stipulations of the parties;

1 5. The interests and welfare of the public school employees
 2 and the financial condition of the public school employer;

3 6. The structure, time, and manner of access of an exclusive
 4 representative to new employee processing in comparable public school employers,
 5 including the access provisions in other memoranda of understanding or collective
 6 bargaining agreements; and

7 7. Any other facts routinely considered in establishing the

10 (3) (i) A request to negotiate under paragraph (2) of this subsection
 11 made between July 1, 2018, and the expiration date of an existing collective bargaining
 12 agreement between the parties shall reopen the existing collective bargaining agreement
 13 only for the purpose of negotiating the access of the exclusive representative to the public
 14 school employer's new employee processing.

15 (ii) Either party may elect to negotiate a separate agreement on the
 16 access of the exclusive representative to the public school employer's new employee
 17 processing in lieu of reopening the existing collective bargaining agreement.

3 **2. AT MORGAN STATE UNIVERSITY, ST. MARY'S**
4 **COLLEGE OF MARYLAND, OR BALTIMORE CITY COMMUNITY COLLEGE, THE**
5 **GOVERNING BOARD OF THE INSTITUTION.**

6 **(4) NOTWITHSTANDING ANY OTHER PROVISION OF LAW:**

7 **(I) MARYLAND TRANSPORTATION AUTHORITY POLICE**
8 **OFFICERS AT THE RANK OF FIRST SERGEANT AND BELOW SHALL HAVE A SEPARATE**
9 **BARGAINING UNIT; AND**

10 **(II) FACULTY AT THE MARYLAND SCHOOL FOR THE DEAF**
11 **SHALL HAVE A SEPARATE BARGAINING UNIT.**

13 **(e) (1) [Negotiations] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
14 **SUBSECTION, NEGOTIATIONS** for a memorandum of understanding shall be considered
15 closed sessions under § 3-305 of the General Provisions Article.

16 **(2) AN EXCLUSIVE REPRESENTATIVE MAY NOT BE CONSIDERED A**
17 **PUBLIC BODY UNDER § 3-101 OF THE GENERAL PROVISIONS ARTICLE.**

19 **(a) Collective bargaining shall include all matters relating to:**

20 **(1) wages, hours, and other terms and conditions of employment; and**

21 **(2) the time and manner of access to a new employee program [as required**
22 **under § 3-307 of this title] IN ACCORDANCE WITH § 21-207 OF THE STATE**
23 **GOVERNMENT ARTICLE.**

24 **(b) [(1) Collective bargaining may include negotiations relating to the right of**
25 **an employee organization to receive service fees from nonmembers.**

26 **(2) An employee whose religious beliefs are opposed to joining or financially**
27 **supporting any collective bargaining organization is:**

28 **(i) not required to pay a service fee; and**

29 **(ii) required to pay an amount of money as determined in collective**
30 **bargaining negotiations, not to exceed any service fee negotiated under paragraph (1) of**

1 this subsection, to any charitable organization exempt from taxation under § 501(c)(3) of
2 the Internal Revenue Code and to furnish written proof of the payment to:

3 1. A. the Department;

4 B. in the case of an employee of the Maryland Environmental
5 Service, the Board of Directors of the Service; or

6 C. in the case of an employee of an institution of higher
7 education specified in § 3–102(a)(1)(v) of this title, the President of the institution or the
8 President’s designee; and

9 2. the exclusive representative.

10 (c) Notwithstanding subsection (a) of this section, the representatives of the
11 State, the Maryland Environmental Service, a system institution, Morgan State
12 University, St. Mary’s College of Maryland, and Baltimore City Community College:

13 (1) [shall] MAY not be required to negotiate over any matter that is
14 inconsistent with applicable law; and

15 (2) may negotiate and reach agreement with regard to any such matter
16 only if it is understood that the agreement with respect to such matter cannot become
17 effective unless the applicable law is amended by the General Assembly.

18 SECTION 5. AND BE IT FURTHER ENACTED, That the terms of the members of
19 the Public Employee Relations Board shall expire as follows:

20 (1) one member appointed under § 21–302(a)(2) of the State Government
21 Article, as enacted by Section 3 of this Act, and one member appointed under § 21–302(a)(3)
22 of the State Government Article, as enacted by Section 3 of this Act, on June 30, 2025;

23 (2) one member appointed under § 21–302(a)(2) of the State Government
24 Article, as enacted by Section 3 of this Act, and one member appointed under § 21–302(a)(3)
25 of the State Government Article, as enacted by Section 3 of this Act, on June 30, 2029; and

26 (3) the chair appointed under § 21–302(a)(1) of the State Government
27 Article, as enacted by Section 4 of this Act, on June 30, 2027.

28 SECTION 6. AND BE IT FURTHER ENACTED, That:

29 (a) The Public Employee Relations Board shall be the successor to the State Labor
30 Relations Board, State Higher Education Labor Relations Board, and Public School Labor
31 Relations Board, and shall have all powers and duties granted by law to those boards.

32 (b) Any investigation, litigation, or other action pending before the State Labor
33 Relations Board, State Higher Education Labor Relations Board, and Public School Labor

1 Relations Board on June 30, 2023 shall continue before the Public Employee Relations
2 Board.

3 SECTION 7. AND BE IT FURTHER ENACTED, That, if any provision of this Act or
4 the application thereof to any person or circumstance is held invalid for any reason in a
5 court of competent jurisdiction, the invalidity does not affect other provisions or any other
6 application of this Act that can be given effect without the invalid provision or application,
7 and for this purpose the provisions of this Act are declared severable.

8 SECTION 8. AND BE IT FURTHER ENACTED, That this Act shall take effect July
9 1, 2023.
