A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Class B-HTF (Hatchet Throwing**
3 **Facility) License**

4 FOR the purpose of establishing a Class B-HTF (hatchet throwing facility) beer and wine
5 license in Harford County that authorizes certain hatchet throwing facilities to sell
6 beer and wine at retail for on-premises consumption; and generally relating to
7 alcoholic beverages licenses in Harford County.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That Section(s) 22–1004.1 of Article – Alcoholic Beverages of the Annotated Code of
26 Maryland be renumbered to be Section(s) 22–1004.2.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
2 as follows:

3 **Article – Alcoholic Beverages**

4 22–102.

5 This title applies only in Harford County.

6 **22–1004.1.**

7 **(A) THERE IS A CLASS B–HTF (HATCHET THROWING FACILITY) BEER AND**
8 **WINE LICENSE.**

9 **(B) THE BOARD MAY ISSUE THE LICENSE FOR USE BY A HATCHET**
10 **THROWING FACILITY THAT:**

11 **(1) IS OPEN TO THE PUBLIC; AND**

12 **(2) HAS AT LEAST SEVEN HATCHET THROWING PITS.**

13 **(C) THE LICENSE AUTHORIZES THE HOLDER TO SELL OR SERVE BEER AND**
14 **WINE AT RETAIL FOR ON–PREMISES CONSUMPTION.**

15 **(D) THE LICENSE HOLDER MAY SELL OR SERVE BEER AND WINE ON**
16 **MONDAY THROUGH SUNDAY, FROM 8 A.M. TO 2 A.M. THE FOLLOWING DAY.**

17 **(E) THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.**

18 **(F) THE LICENSE HOLDER IS SUBJECT TO THE ALCOHOL AWARENESS**
19 **TRAINING REQUIREMENTS UNDER § 4–505 OF THIS ARTICLE.**

20 **(G) THE LICENSE HOLDER SHALL PURCHASE BEER AND WINE FROM A**
21 **RETAIL LICENSE HOLDER OR AN AUTHORIZED AND LICENSED WHOLESALER OR**
22 **MANUFACTURER.**

23 **(H) THE LICENSE HOLDER SHALL PROVIDE PREPACKAGED SNACKS FOR**
24 **PURCHASE AT ALL TIMES WHEN BEER AND WINE ARE SOLD.**

25 **(I) THE ANNUAL LICENSE FEE IS \$750.**

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
27 1, 2023.
