1 AN ACT concerning

2 **Hate Crimes – Commission on Hate Crime Response and Prevention –**
3 **Establishment**

4 FOR the purpose of establishing the Commission on Hate Crime Response and Prevention;
5 and generally relating to the Commission on Hate Crime Response and Prevention.

6 BY adding to

7 Article – State Government

8 Section 6–701 and 6–702 to be under the new subtitle “Subtitle 7. Commission on
9 Hate Crime Response and Prevention”

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – State Government**

15 **SUBTITLE 7. COMMISSION ON HATE CRIME RESPONSE AND PREVENTION.**

16 **6–701.**

17 **IN THIS SUBTITLE, “COMMISSION” MEANS THE COMMISSION ON HATE CRIME**
18 **RESPONSE AND PREVENTION.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

2 (A) THERE IS A COMMISSION ON HATE CRIME RESPONSE AND
3 PREVENTION IN THE OFFICE OF THE ATTORNEY GENERAL.

4 (B) THE COMMISSION CONSISTS OF THE FOLLOWING MEMBERS,
5 APPOINTED BY THE ATTORNEY GENERAL:

6 (1) ONE REPRESENTATIVE OF THE ANTI-DEFAMATION LEAGUE;

7 (2) ONE REPRESENTATIVE OF THE ASIAN AMERICAN AND PACIFIC
8 ISLANDER COMMUNITY;

9 (3) ONE REPRESENTATIVE OF THE BALTIMORE COUNTY
10 DEPARTMENT OF DIVERSITY AND INCLUSION;

11 (4) ONE REPRESENTATIVE OF THE BALTIMORE JEWISH COUNCIL;

12 (5) ONE REPRESENTATIVE OF THE COALITION OPPOSED TO
13 VIOLENCE AND EXTREMISM;

14 (6) ONE REPRESENTATIVE OF THE COUNCIL ON AMERICAN-ISLAMIC
15 RELATIONS MARYLAND OFFICE;

16 (7) ONE REPRESENTATIVE OF FREE STATE JUSTICE;

17 (8) ONE REPRESENTATIVE OF THE JEWISH COMMUNITY RELATIONS
18 COUNCIL;

19 (9) ONE REPRESENTATIVE OF THE IMMIGRATION OUTREACH
20 SERVICE CENTER;

21 (10) ONE REPRESENTATIVE OF THE MARYLAND ASSOCIATION OF
22 HUMAN RELATIONS/HUMAN RIGHTS AGENCIES;

23 (11) ONE REPRESENTATIVE OF THE MARYLAND CHIEFS OF POLICE
24 ASSOCIATION;

25 (12) ONE REPRESENTATIVE OF THE MARYLAND COMMISSION ON
26 CIVIL RIGHTS;

1 **(13) ONE REPRESENTATIVE OF THE MARYLAND COORDINATION AND**
2 **ANALYSIS CENTER;**

3 **(14) ONE REPRESENTATIVE OF THE MARYLAND CENTER FOR SCHOOL**
4 **SAFETY;**

5 **(15) ONE REPRESENTATIVE OF THE MARYLAND SHERIFFS'**
6 **ASSOCIATION;**

7 **(16) ONE REPRESENTATIVE OF THE MARYLAND STATE'S ATTORNEYS'**
8 **ASSOCIATION;**

9 **(17) ONE REPRESENTATIVE OF THE NATIONAL ALLIANCE ON MENTAL**
10 **ILLNESS;**

11 **(18) ONE REPRESENTATIVE OF THE NATIONAL ASSOCIATION FOR THE**
12 **ADVANCEMENT OF COLORED PEOPLE;**

13 **(19) ONE REPRESENTATIVE OF THE PRIDE CENTER OF MARYLAND;**

14 **(20) ONE REPRESENTATIVE OF THE SIKH COALITION; AND**

15 **(21) TWO MEMBERS OF THE GENERAL PUBLIC.**

16 **(C) (1) THE TERM OF AN APPOINTED MEMBER OF THE COMMISSION IS 4**
17 **YEARS.**

18 **(2) THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED AS**
19 **REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE COMMISSION ON JUNE**
20 **1, 2023.**

21 **(3) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES TO**
22 **SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

23 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
24 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
25 **QUALIFIES.**

26 **(D) (1) THE ATTORNEY GENERAL, OR THE ATTORNEY GENERAL'S**
27 **DESIGNEE, IS THE CHAIR OF THE COMMISSION.**

28 **(2) THE OFFICE OF THE ATTORNEY GENERAL SHALL PROVIDE STAFF**
29 **FOR THE COMMISSION.**

1 **(E) IN FISCAL YEAR 2025 AND IN EACH FISCAL YEAR THEREAFTER, THE**
2 **GOVERNOR SHALL INCLUDE FUNDS IN THE STATE BUDGET TO IMPLEMENT THIS**
3 **SECTION, INCLUDING FUNDS TO:**

4 **(1) EMPLOY A FULL-TIME ASSISTANT ATTORNEY GENERAL TO STAFF**
5 **THE COMMISSION; AND**

6 **(2) OPERATE AND MAINTAIN THE OFFICE.**

7 **(F) (1) A MAJORITY OF MEMBERS OF THE COMMISSION SHALL**
8 **CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS.**

9 **(2) THE COMMISSION MAY ADOPT RULES GOVERNING THE**
10 **ADMINISTRATION AND PROCEEDINGS OF THE COMMISSION.**

11 **(G) A MEMBER OF THE COMMISSION:**

12 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
13 **COMMISSION; BUT**

14 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
15 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

16 **(H) THE COMMISSION SHALL:**

17 **(1) DEVELOP STRATEGIES TO PREVENT AND RESPOND TO HATE**
18 **CRIME ACTIVITY; AND**

19 **(2) EVALUATE STATE LAWS AND POLICIES RELATING TO HATE**
20 **CRIMES.**

21 **(I) (1) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2024,**
22 **THE COMMISSION SHALL REPORT TO THE STATE DEPARTMENT OF EDUCATION ON**
23 **POLICY RECOMMENDATIONS TO ADDRESS HATE CRIMES THAT OCCUR IN SCHOOLS.**

24 **(2) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2024,**
25 **THE COMMISSION SHALL REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE**
26 **WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON LEGISLATIVE**
27 **RECOMMENDATIONS TO ADDRESS HATE CRIMES IN THE STATE.**

28 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
29 appointed members of the Commission on Hate Crime Response and Prevention shall
30 expire as follows:

- 1 (1) five members in 2024;
- 2 (2) five members in 2025;
- 3 (3) six members in 2026; and
- 4 (4) six members in 2027.

5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June
6 1, 2023.
