12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – State Government**

3 **IN THIS SUBTITLE, “COMMISSION” MEANS THE COMMISSION ON HATE CRIME**
4 **RESPONSE AND PREVENTION.**

5 **6-702.**

6 **(A) THERE IS A COMMISSION ON HATE CRIME RESPONSE AND**
7 **PREVENTION IN THE OFFICE OF THE ATTORNEY GENERAL.**

8 **(B) THE COMMISSION CONSISTS OF THE FOLLOWING MEMBERS,**
9 **APPOINTED BY THE ATTORNEY GENERAL:**

10 **(1) ONE REPRESENTATIVE OF THE ANTI-DEFAMATION LEAGUE;**

11 **(2) ONE REPRESENTATIVE OF THE ASIAN AMERICAN AND PACIFIC**
12 **ISLANDER COMMUNITY;**

13 **(3) ONE REPRESENTATIVE OF THE ~~BALTIMORE COUNTY~~**
14 **~~DEPARTMENT OF DIVERSITY AND INCLUSION~~ WOMEN’S LAW CENTER;**

15 **(4) ONE REPRESENTATIVE OF THE BALTIMORE JEWISH COUNCIL;**

5 **(14) ONE REPRESENTATIVE OF THE MARYLAND CENTER FOR SCHOOL**
6 **SAFETY;**

7 **(15) ONE REPRESENTATIVE OF THE MARYLAND SHERIFFS'**
8 **ASSOCIATION;**

9 **(16) ONE REPRESENTATIVE OF THE MARYLAND STATE'S ATTORNEYS'**
10 **ASSOCIATION;**

11 **(17) ONE REPRESENTATIVE OF THE NATIONAL ALLIANCE ON MENTAL**
12 **ILLNESS;**

13 **(18) ONE REPRESENTATIVE OF THE NATIONAL ASSOCIATION FOR THE**
14 **ADVANCEMENT OF COLORED PEOPLE;**

15 **(19) ONE REPRESENTATIVE OF THE PRIDE CENTER OF MARYLAND;**

16 **(20) ONE REPRESENTATIVE OF THE SIKH COALITION; AND**

17 **(21) TWO MEMBERS OF THE GENERAL PUBLIC.**

18 **(C) (1) THE TERM OF AN APPOINTED MEMBER OF THE COMMISSION IS 4**
19 **YEARS.**

20 **(2) THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED AS**
21 **REQUIRED BY THE TERMS PROVIDED FOR MEMBERS OF THE COMMISSION ON JUNE**
22 **1, 2023.**

23 **(3) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES TO**
24 **SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

25 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
26 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
27 **QUALIFIES.**

28 **(D) (1) THE ATTORNEY GENERAL, OR THE ATTORNEY GENERAL'S**
29 **DESIGNEE, IS THE CHAIR OF THE COMMISSION.**

1 **(2) THE OFFICE OF THE ATTORNEY GENERAL SHALL PROVIDE STAFF**
2 **FOR THE COMMISSION.**

3 **(E) IN FISCAL YEAR 2025 AND IN EACH FISCAL YEAR THEREAFTER, THE**
4 **GOVERNOR SHALL INCLUDE FUNDS IN THE STATE BUDGET TO IMPLEMENT THIS**
5 **SECTION, INCLUDING FUNDS TO:**

6 **(1) EMPLOY A FULL-TIME ASSISTANT ATTORNEY GENERAL TO STAFF**
7 **THE COMMISSION; AND**

8 **(2) OPERATE AND MAINTAIN THE OFFICE.**

9 **(F) (1) A MAJORITY OF MEMBERS OF THE COMMISSION SHALL**
10 **CONSTITUTE A QUORUM FOR THE TRANSACTION OF BUSINESS.**

11 **(2) THE COMMISSION MAY ADOPT RULES GOVERNING THE**
12 **ADMINISTRATION AND PROCEEDINGS OF THE COMMISSION.**

13 **(G) A MEMBER OF THE COMMISSION:**

14 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
15 **COMMISSION; BUT**

16 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
17 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

18 **(H) THE COMMISSION SHALL:**

19 **(1) DEVELOP STRATEGIES TO PREVENT AND RESPOND TO HATE**
20 **CRIME ACTIVITY; AND**

21 **(2) EVALUATE STATE LAWS AND POLICIES RELATING TO HATE**
22 **CRIMES.**

23 **(I) (1) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2024,**
24 **THE COMMISSION SHALL REPORT TO THE STATE DEPARTMENT OF EDUCATION ON**
25 **POLICY RECOMMENDATIONS TO ADDRESS HATE CRIMES THAT OCCUR IN SCHOOLS.**

26 **(2) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2024,**
27 **THE COMMISSION SHALL REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE**
28 **WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, ON LEGISLATIVE**
29 **RECOMMENDATIONS TO ADDRESS HATE CRIMES IN THE STATE.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
2 appointed members of the Commission on Hate Crime Response and Prevention shall
3 expire as follows:

4 (1) five members in 2024;

5 (2) five members in 2025;

6 (3) six members in 2026; and

7 (4) six members in 2027.

8 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June
9 1, 2023.
