16 A person, while hunting for any wild bird or mammal, may not shoot or (2)17discharge any firearm within 300 yards of a public or nonpublic school during school hours 18or at a time when a school–approved activity is taking place.

19For archery hunters in Allegany County, Calvert County, Carroll (3)(i) 20County, Cecil County, Frederick County, Garrett County, Harford County, Montgomery 21County, St. Mary's County, [or] Washington County, OR WICOMICO COUNTY, the safety 22zone described in paragraph (1) of this subsection extends for 50 yards from a dwelling 23house, residence, church, or any other building or camp occupied by human beings.

24(ii) For archery hunters in Anne Arundel County, the safety zone 25described in paragraph (1) of this subsection extends for 100 yards from a dwelling house, 26residence, church, or any other building or camp occupied by human beings.

27SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 281, 2023.
