## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Town of Sharpsburg – Parking of Vehicles – Restrictions**

3 FOR the purpose of prohibiting a person from parking certain vehicles in the Town of  
4 Sharpsburg, Washington County, subject to a certain exception; and generally  
5 relating to the parking of vehicles in the Town of Sharpsburg, Washington County.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

15 **(A) (1) THIS SECTION APPLIES:**

16 **(I) TO A VEHICLE REGISTERED OR CAPABLE OF BEING**  
17 **REGISTERED:**

2 **CLASS E (TRUCK) VEHICLE UNDER THIS ARTICLE;**

3                   2.     **AS A CLASS F (TRACTOR) VEHICLE UNDER THIS**  
4 **ARTICLE;**

5                   3.     **AS A CLASS G (TRAILER) VEHICLE UNDER THIS**  
6 **ARTICLE;**

7                   4.     **AS A CLASS H (SCHOOL BUS) VEHICLE UNDER THIS**  
8 **ARTICLE; AND**

9                   5.     **AS A CLASS P (PASSENGER BUS) VEHICLE UNDER**

13                   **(2) THIS SECTION DOES NOT APPLY TO ANY VEHICLE THAT IS OF A**  
14 **TYPE CAPABLE OF BEING REGISTERED:**

15                   **(I) AS A CLASS A (PASSENGER) VEHICLE UNDER § 13-912 OF**  
16 **THIS ARTICLE; OR**

17                   **(II) AS A CLASS E (TRUCK) VEHICLE UNDER § 13-917 OF THIS**  
18 **ARTICLE.**

19                   **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**  
20 **PERSON MAY NOT PARK A VEHICLE ON ANY STREET OR HIGHWAY.**

21                   **(2) THIS SUBSECTION DOES NOT APPLY IF THE PARKING OF THE**  
22 **VEHICLE IS ESSENTIAL TO THE IMMEDIATE USE THEN BEING MADE OF THE VEHICLE.**

23                   **(C) (1) IN THE CASE OF A COMBINATION TRACTOR AND TRAILER, A**  
24 **PERSON WHO VIOLATES THIS SECTION IS SUBJECT TO A SEPARATE FINE FOR EACH**  
25 **VEHICLE.**

26                   **(2) FOR THE PURPOSE OF DETERMINING THE PENALTY UNDER THIS**  
27 **SECTION, EACH DAY OF A VIOLATION IS A SEPARATE OFFENSE.**

28                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 October 1, 2023.
