A BILL ENTITLED

1 AN ACT concerning

2 Special Education – Judicial Actions – Attorney's Fees and Related Costs

FOR the purpose of authorizing a court to award attorney's fees and related costs to the parent of a child with a disability who is the prevailing party in a certain special education proceeding; prohibiting a court from awarding attorney's fees and related costs to certain parents in a certain proceeding under certain circumstances; authorizing an award of attorney's fees and related costs to a parent of a child with a disability who is a prevailing party under certain circumstances; and generally relating to attorney's fees and related costs in special education proceedings.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 9 (2) A resolution session agreement shall be in writing and enforceable in a 10 court of competent jurisdiction in accordance with federal law.
- (3) A written resolution agreement may be voided by the parties within 3
 business days of execution in accordance with federal law.

13 (d) (1) A parent of a child with disabilities shall file a due process complaint 14 with the Office of Administrative Hearings and the public agency.

15 (2) A public agency shall file a due process complaint with the Office of 16 Administrative Hearings and the parent.

17 (3) Except as provided in paragraph (4) of this subsection, the complaining 18 party shall file a due process complaint within 2 years of the date the party knew or should 19 have known about the action that forms the basis of the due process complaint.

20 (4) The statute of limitations described under paragraph (3) of this 21 subsection does not apply to a parent who is prevented from requesting a due process 22 hearing due to:

(i) Specific misrepresentations made by the public agency that it
 had resolved the problem that formed the basis of the due process complaint; or

(ii) The public agency's withholding of information that the publicagency was required to provide to the parent.

(5) In order to conduct a hearing, the Office of Administrative Hearingsshall appoint an administrative law judge who:

(i) Is an administrative law judge in the Office of AdministrativeHearings; and

31 (ii) Meets the requirements of a due process hearing officer in 32 accordance with federal law.

1 (6) Unless the parent and the public agency otherwise agree, during the 2 course of any administrative or judicial proceeding, the child must remain in the last 3 approved placement in accordance with federal law.

4 (7) If the hearing concerns the initial admission of a child into a public 5 school, the child with the consent of the parent must be placed in the public school program 6 until the proceedings have been completed.

7 (e) (1) The administrative law judge appointed under subsection (d) of this 8 section shall conduct the hearing in accordance with federal law, Title 10 of the State 9 Government Article, and the Office of Administrative Hearings Rules of Administrative 10 Procedure, and may:

(i) After review of the educational records of the child, dismiss any
request for review which does not relate to a matter described in subsection (d)(1) of this
section;

(iii) Hear any testimony that it considers relevant;

(iv) Require an independent evaluation or call an impartial expert
witness in the diagnosis or education of students with disabilities whose testimony shall be
on the record and whose costs shall be paid by the State Education Agency; and

20 (v) Administer oaths to witnesses at the hearing on request of a 21 party.

(2) The provisions of the Family Educational Rights and Privacy Act and
 34 C.F.R. Part 99 shall apply to school records sought by the impartial expert witness.

(3) If the parties cannot agree on an impartial expert witness, each party
shall be given the opportunity to submit a list of possible experts, and the administrative
law judge shall decide which impartial expert witness to call.

1 (2) If the parent of a child with a disability, who previously received special 2 education and related services under the authority of a public agency, enrolls the child in 3 a nonpublic school or facility without the consent of or referral by the public agency, an 4 administrative law judge or a court may require the public agency to reimburse the parent 5 for the costs of the placement enrollment if the administrative law judge or court 6 determines that the public agency had not made a free appropriate public education 7 available to the child in a timely manner prior to that enrollment.

18(I)THE SETTLEMENT OFFER IS MADE MORE THAN 14 DAYS19BEFORE THE START OF THE PROCEEDING;

(III) THE COURT FINDS THAT THE RELIEF FINALLY OBTAINED BY
 THE PARENT IS NOT MORE FAVORABLE TO THE PARENT THAN THE SETTLEMENT
 OFFER.

(3) AN AWARD OF ATTORNEY'S FEES AND RELATED COSTS,
INCLUDING EXPERT WITNESS FEES AND COSTS, MAY BE MADE TO A PARENT WHO IS
THE PREVAILING PARTY AND WHO WAS SUBSTANTIALLY JUSTIFIED IN REJECTING A
SETTLEMENT OFFER.
