- 3 FOR the purpose of establishing the Protecting Against Hate Crimes Grant Fund as a 4 special, nonlapsing fund to make grants to nonprofit organizations, including 5 faith-based organizations, to provide security enhancements to protect against hate 6 crimes; requiring the Executive Director of the Governor's Office of Crime 7 Prevention, Youth, and Victim Services to administer the Fund; requiring, for fiscal 8 year 2025 and each fiscal year thereafter, the Governor to include in the annual 9 budget bill a certain appropriation to the Fund; and generally relating to the Protecting Against Hate Crimes Grant Fund. 10

- 10 (A) IN THIS SECTION, "FUND" MEANS THE PROTECTING AGAINST HATE 11 CRIMES GRANT FUND.

- 13 (C) THE PURPOSE OF THE FUND IS TO MAKE GRANTS TO NONPROFIT

- 30 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
- 31 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

- 1 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 2 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.
- 3 **(F)** THE FUND CONSISTS OF:
- 4 (1) MONEY APPROPRIATED IN THE STATE BUDGET TO THE FUND;
- 5 (2) ANY INTEREST EARNINGS OF THE FUND; AND
- 6 (3) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR 7 THE BENEFIT OF THE FUND.
- 8 (G) THE FUND MAY BE USED ONLY TO MAKE GRANTS TO NONPROFIT 9 ORGANIZATIONS, INCLUDING FAITH-BASED ORGANIZATIONS, TO PROVIDE 10 SECURITY ENHANCEMENTS TO PROTECT AGAINST HATE CRIMES.
- 11 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND 12 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.
- 13 (2) ANY INTEREST EARNINGS OF THE FUND, INCLUDING INTEREST EARNINGS UNDER SUBSECTION (F) OF THIS SECTION, SHALL BE CREDITED TO THE FUND.
- 16 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE 17 WITH THE STATE BUDGET.
- (J) MONEY EXPENDED FROM THE FUND FOR GRANTS TO NONPROFIT ORGANIZATIONS TO PROVIDE SECURITY ENHANCEMENTS TO PROTECT AGAINST HATE CRIMES IS SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE APPROPRIATED FOR PROVIDING NONPROFIT ORGANIZATIONS WITH SECURITY ENHANCEMENTS TO PROTECT AGAINST HATE CRIMES.
- 24 (K) FOR FISCAL YEAR 2025 AND EACH FISCAL YEAR THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$5,000,000 TO THE FUND.
