3 FOR the purpose of requiring certain county boards of education to consider the pursuit of 4 certain certificates, certifications, or apprenticeships as the equivalent of pursuing $\mathbf{5}$ postsecondary education and provide a method for certain individuals to authorize 6 the release of certain student information to certain apprenticeship sponsors and 7 employers; requiring each public high school to inform students of certain 8 employment and skills training opportunities in a certain manner; requiring a 9 county board to pay for a student to take an apprenticeship entrance exam or industrial certification exam under certain circumstances; and generally relating to 1011 career education and apprenticeships.

1 (A) IN THIS SECTION, "PLATFORM" MEANS A COLLEGE AND CAREER 2 READINESS SOFTWARE PROGRAM THAT HELPS SCHOOL SYSTEMS AND SCHOOLS 3 ALIGN STUDENT STRENGTHS AND INTERESTS TO POSTSECONDARY GOALS AND 4 CAREERS.

(B) A COUNTY BOARD THAT USES A PLATFORM SHALL:

1 [(b)] (2) Subject to the availability of funding in the State budget, the amount of 2 each county's grant shall be in an amount sufficient for the administration of the test to all 3 10th grade students in the county.

4 (B) (1) (I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE 5 MEANINGS INDICATED.

6 (II) "APPRENTICESHIP ENTRANCE EXAM" MEANS THE 7 TRADE–SPECIFIC ASSESSMENT USED TO EVALUATE A STUDENT'S BASIC APTITUDE 8 BEFORE THE STUDENT BEGINS THE PRACTICAL AND TECHNICAL TRAINING PHASE 9 OF AN APPRENTICESHIP.

10 (III) "INDUSTRIAL **CERTIFICATION** EXAM" **MEANS** THE 11 INDUSTRY-RECOGNIZED ASSESSMENT DOCUMENTS STUDENT'S THAT Α 12PERFORMANCE AND ACHIEVEMENT OF INDUSTRY STANDARDS AND RESULTS IN THE RECEIPT OF A CERTIFICATE, A LICENSE, OR ANY OTHER CREDENTIAL. 13

14 (2) IF A COUNTY BOARD PAYS FOR ANY STUDENT TO TAKE AN 15 ADVANCED PLACEMENT EXAMINATION, A PRELIMINARY SCHOLASTIC APTITUDE 16 TEST/NATIONAL MERIT SCHOLARSHIP QUALIFYING TEST, OR A SCHOLASTIC 17 APTITUDE TEST, THE COUNTY BOARD SHALL PAY FOR A STUDENT TO TAKE AN 18 APPRENTICESHIP ENTRANCE EXAM OR INDUSTRIAL CERTIFICATION EXAM.
