1 (2) Each application shall provide a space for an applicant to sign an 2 acknowledgment of the notice required under this subsection.

3 (e) An applicant shall sign the acknowledgment of the notice required under 4 subsection (d) of this section.

5 (f) If an employer violates subsection (c) or (d) of this section, an applicant for 6 employment or prospective employment or an employee may submit to the Commissioner 7 a written complaint.

8 (g) (1) Whenever the Commissioner determines that this section has been 9 violated, the Commissioner may:

10 (i) try to resolve any issue involved in the violation informally by11 mediation; or

12 (ii) ask the Attorney General to bring an action on behalf of the 13 applicant or employee.

14 (2) The Attorney General may bring an action under this section in the 15 county where the violation allegedly occurred, for injunctive relief, damages, or other relief.

16 (h) An employer who violates any provision of this section is guilty of a 17 misdemeanor and on conviction is subject to a fine not exceeding \$100.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2023.
