A BILL ENTITLED

1 AN ACT concerning

2 **Primary and Secondary Education – Virtual Education – Requirements**

3 FOR the purpose of requiring a teacher preparation program to include certain training
4 related to teaching in a virtual learning environment as a component of instruction;
5 providing that a county board of education may authorize a county superintendent
6 of schools, under certain circumstances, to provide virtual education days to students
7 instead of closing the public schools in the county because of severe weather
8 conditions; requiring the county board to publish the county board’s plan for the use
9 of virtual education days on the school system’s website and requiring the plan to
10 include certain items; requiring a county superintendent to take certain actions and
11 make certain accommodations if the county superintendent decides to provide a
12 virtual education day for public school students in the county; requiring the State
13 Department of Education, on or before a certain date, to establish a statewide
14 universal learning management system for public schools and hire a dedicated
15 employee to implement and manage the system; authorizing a county board to adopt
16 the universal learning management system under certain circumstances; requiring
17 the Department, beginning in a certain school year, to make certain curriculum
18 standards available through the universal management learning system; altering
19 the requirements for virtual schools established by a county board; requiring county
20 boards to adopt virtual education plans for the operation of public schools during a
21 prolonged state of emergency; providing for the contents of a virtual education plan;
22 requiring public schools to establish certain learning supports and a behavioral
23 health plan under certain circumstances; requiring the Department to establish
24 certain training standards for teachers on the provision of virtual education under
25 certain circumstances; requiring the Department to expand computer and Internet
26 security infrastructure for virtual education; requiring a community school to
27 address and mitigate the effects of learning loss and chronic absenteeism caused by
28 school closures; requiring the State Superintendent of Schools to report to the State
29 Board of Education and the General Assembly on or before a certain date certain
30 findings and recommendations regarding the balance between certain types of
31 learning in virtual schools; providing that certain virtual schools approved by the

1 Department on or before a certain date may continue to operate as a virtual school
2 for a certain period of time under certain circumstances; requiring the Department,
3 in consultation with certain stakeholders, to study best practices for the provision of
4 virtual education and submit a certain report on or before a certain date; prohibiting
5 the approval of a new elementary grade band virtual school on or before a certain
6 date; and generally relating to virtual education in the State.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Education**

22 6–121.

23 (a) A teacher preparation program shall:

24 (1) Include the following components of instruction:

25 (i) Basic research skills and methods and training on the routine
26 evaluation and use of research and data to improve student performance;

27 (ii) Differentiation of instruction and demonstration of cultural
28 competence for students of diverse racial, ethnic, linguistic, and economic backgrounds with
29 different learning abilities;

30 (iii) Implementation of restorative approaches for student behaviors;

31 (iv) Identifying and assessing, in the context of the classroom, typical
32 student learning deficits and techniques to remedy learning deficits;

33 (v) Recognizing and effectively using high quality instructional
34 materials, including digital resources and computer technology;

1 (vi) Core academic subjects that teachers will be teaching;

2 (vii) Methods and techniques for identifying and addressing the social
3 and emotional needs of students, including trauma-informed approaches to pedagogy;
4 [and]

5 (viii) Skills and techniques for effective classroom management; AND

6 **(IX) TRAINING IN THE SKILLS AND TECHNIQUES FOR TEACHING**
7 **EFFECTIVELY IN A VIRTUAL LEARNING ENVIRONMENT;**

8 (2) Require program participants to demonstrate competency in each of the
9 components required under paragraph (1) of this subsection;

10 (3) Provide training in the knowledge and skills required to understand
11 and teach the Maryland curriculum frameworks; and

12 (4) On or after July 1, 2025, require passing a nationally recognized,
13 portfolio-based assessment of teaching ability as a requirement for graduation.

15 **(A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A COUNTY BOARD MAY**
16 **AUTHORIZE THE COUNTY SUPERINTENDENT, IN CASES OF SEVERE WEATHER**
17 **CONDITIONS, TO PROVIDE VIRTUAL EDUCATION DAYS TO STUDENTS INSTEAD OF**
18 **CLOSING THE PUBLIC SCHOOLS IN THE COUNTY DURING A SEVERE WEATHER EVENT.**

19 **(B) BEFORE A COUNTY BOARD MAY AUTHORIZE THE COUNTY**
20 **SUPERINTENDENT TO PROVIDE VIRTUAL EDUCATION DAYS TO STUDENTS IN**
21 **ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION, THE COUNTY BOARD SHALL:**

22 **(1) DISCUSS THIS TOPIC AT AN OPEN MEETING; AND**

23 **(2) VOTE AFFIRMATIVELY TO AUTHORIZE THE COUNTY**
24 **SUPERINTENDENT TO PROVIDE VIRTUAL EDUCATION DAYS TO STUDENTS DURING A**
25 **SEVERE WEATHER EVENT.**

26 **(C) (1) A COUNTY BOARD SHALL PUBLISH THE COUNTY BOARD'S PLAN**
27 **FOR THE USE OF VIRTUAL EDUCATION DAYS ON THE SCHOOL SYSTEM'S WEBSITE.**

28 **(2) THE COUNTY BOARD'S PLAN PUBLISHED IN ACCORDANCE WITH**
29 **PARAGRAPH (1) OF THIS SUBSECTION SHALL INCLUDE:**

30 **(I) A PLAN TO ENSURE THAT ATTENDANCE WILL BE TAKEN FOR**
31 **ALL STUDENTS AND TEACHERS DURING EACH VIRTUAL EDUCATION DAY;**

1 **(II) A PLAN TO PROVIDE OPPORTUNITIES FOR STUDENTS TO**
2 **MAKE UP WORK MISSED DURING VIRTUAL EDUCATION DAYS WHEN THEY RETURN TO**
3 **IN-PERSON SCHOOL;**

4 **(III) A PLAN TO ENSURE THAT ALL STAFF AND STUDENTS,**
5 **INCLUDING STUDENTS WITH DISABILITIES, HOMELESS STUDENTS, AND ENGLISH**
6 **LANGUAGE LEARNERS, HAVE THE NECESSARY DEVICES AT HOME FOR VIRTUAL**
7 **EDUCATION DAYS, INCLUDING ACCESS TO WI-FI; AND**

8 **(IV) SPECIFIC STRATEGIES FOR THE CONTINUED**
9 **IMPLEMENTATION OF INDIVIDUALIZED EDUCATION PROGRAMS DURING THE**
10 **VIRTUAL EDUCATION DAY, INCLUDING SPECIALLY DESIGNED INSTRUCTION,**
11 **RELATED SERVICES, SUPPLEMENTARY AIDS AND SERVICES, AND**
12 **ACCOMMODATIONS.**

13 **(D) A COUNTY SUPERINTENDENT MAY DECIDE TO PROVIDE A DAY OF**
14 **VIRTUAL EDUCATION FOR PUBLIC SCHOOL STUDENTS IN THE COUNTY ONLY IF:**

15 **(1) THE LOCAL SCHOOL SYSTEM HAS USED ALL THE DAYS**
16 **INCORPORATED INTO ITS CALENDAR FOR SCHOOL CLOSURES FOR SEVERE**
17 **WEATHER CONDITIONS;**

18 **(2) THE COUNTY BOARD HAS AUTHORIZED THE COUNTY**
19 **SUPERINTENDENT TO PROVIDE VIRTUAL EDUCATION DAYS TO STUDENTS IN**
20 **ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION; AND**

21 **(3) THE COUNTY SUPERINTENDENT DETERMINES THAT SEVERE**
22 **WEATHER CONDITIONS ARE LIKELY TO PREVENT NORMAL ATTENDANCE AT THE**
23 **PUBLIC SCHOOL.**

24 **(E) (1) IF A COUNTY SUPERINTENDENT DECIDES TO PROVIDE A VIRTUAL**
25 **EDUCATION DAY FOR PUBLIC SCHOOL STUDENTS IN THE COUNTY, THE COUNTY**
26 **SUPERINTENDENT SHALL NOTIFY THE SCHOOL PRINCIPALS AS SOON AS POSSIBLE**
27 **AFTER THE DECISION IS MADE.**

28 **(2) A SCHOOL PRINCIPAL WHO RECEIVES NOTICE OF A VIRTUAL**
29 **EDUCATION DAY IMMEDIATELY SHALL NOTIFY THE STUDENTS, PARENTS, AND**
30 **SCHOOL STAFF OF THE IMPLEMENTATION OF THE VIRTUAL EDUCATION DAY.**

31 **(F) (1) A VIRTUAL EDUCATION DAY SHALL CONSIST OF NOT LESS THAN 4**
32 **HOURS OF SYNCHRONOUS INSTRUCTION, AND ASYNCHRONOUS INSTRUCTION**
33 **DESIGNED TO MAXIMIZE THE ADVANTAGES OF ONLINE ACCESS.**

1 **(2) A COUNTY SUPERINTENDENT SHALL ADEQUATELY DESIGN THE**
2 **VIRTUAL EDUCATION DAY MODEL BEFORE IMPLEMENTATION OF THE FIRST**
3 **VIRTUAL EDUCATION DAY.**

4 7–202.1.

5 (a) The Department shall, in consultation with experienced and highly effective
6 teachers, including teachers on the career ladder under Title 6, Subtitle 10 of this article,
7 develop curriculum standards and curriculum resources for each subject at each grade
8 level, that build on one another in logical sequence, in core subjects that may be used by
9 local school systems and public school teachers.

10 (b) (1) The purpose of the curriculum standards and curriculum resources
11 developed under this section is to provide county boards with technical assistance to inform
12 high-quality instruction that will ultimately result in students meeting the college and
13 career readiness standards in the manner described under § 7–205.1 of this subtitle.

14 (2) The curriculum resources developed under this section shall include,
15 for each core subject at each grade level:

16 (i) Course syllabi;

17 (ii) Sample lessons for teachers to use as models;

18 (iii) Examples of student work that meet standards for proficiency;

19 (iv) Explanations of why student work examples meet proficiency
20 standards so that teachers know what student knowledge is required; and

21 (v) Curriculum units aligned with the course syllabi.

22 (3) In developing the curriculum resources under this subsection, the
23 Department:

24 (i) May use as a model a course or unit developed by a teacher in or
25 out of the State; but

26 (ii) Shall review each model course and unit for quality, using
27 accepted benchmarks such as approval by EdReports or Tier 1 and Tier 2 evidence-based
28 standards established by the federal Every Student Succeeds Act.

29 (4) The Department shall compile curriculum units in such a manner that:

30 (i) Complete courses are formed; and

1 (ii) When taken by a student in sequence, the student can achieve
2 the college and career readiness standard adopted under § 7–205.1 of this subtitle by the
3 end of grade 10.

4 (c) The Department shall submit curriculum resources and curriculum standards
5 developed under this section to the State Board for adoption.

6 (d) **(1) (I) ON OR BEFORE SEPTEMBER 1, 2023, THE DEPARTMENT**
7 **SHALL:**

8 **1. ESTABLISH A STATEWIDE UNIVERSAL LEARNING**
9 **MANAGEMENT SYSTEM FOR EVENTUAL USE IN ALL PUBLIC SCHOOLS IN THE STATE;**
10 **AND**

11 **2. HIRE A DEDICATED EMPLOYEE TO IMPLEMENT AND**
12 **MANAGE THE UNIVERSAL LEARNING MANAGEMENT SYSTEM.**

13 **(II) IF A COUNTY BOARD HAS NOT, ON OR BEFORE AUGUST 31,**
14 **2023, CONTRACTED TO LICENSE A LEARNING MANAGEMENT SYSTEM OTHER THAN**
15 **THE UNIVERSAL LEARNING MANAGEMENT SYSTEM ESTABLISHED BY THE**
16 **DEPARTMENT UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE COUNTY**
17 **BOARD MAY ADOPT THE UNIVERSAL LEARNING MANAGEMENT SYSTEM**
18 **ESTABLISHED BY THE DEPARTMENT.**

19 **(III) THE DEPARTMENT SHALL PROVIDE TECHNICAL SUPPORT,**
20 **AID WITH PROFESSIONAL DEVELOPMENT, AND FINANCIAL SUPPORT TO A COUNTY**
21 **BOARD THAT ADOPTS THE UNIVERSAL LEARNING MANAGEMENT SYSTEM**
22 **ESTABLISHED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

23 **(IV) THE DEPARTMENT MAY NOT PROVIDE LEARNING**
24 **MANAGEMENT–BASED SUPPORT TO A COUNTY BOARD THAT DOES NOT ADOPT THE**
25 **UNIVERSAL LEARNING MANAGEMENT SYSTEM ESTABLISHED UNDER**
26 **SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

27 **(2) BEGINNING IN THE 2025–2026 SCHOOL YEAR, THE DEPARTMENT**
28 **SHALL MAKE THE CURRICULUM STANDARDS DEVELOPED UNDER THIS SECTION**
29 **AVAILABLE THROUGH THE UNIVERSAL LEARNING MANAGEMENT SYSTEM.**

30 **(E)** The State Board shall establish a system of assessments to ensure that
31 students are acquiring the knowledge contained in the curriculum standards in English,
32 Mathematics, Science, and History or Social Studies.

33 **[(e)] (F) (1)** Using the assessments established under subsection **[(d)] (E)** of
34 this section, the Department shall identify low–performing schools.

1 (2) An Expert Review Team established under § 5–411 of this article, under
2 the supervision of the Department, shall visit schools identified under paragraph (1) of this
3 subsection according to the criteria established under § 5–411 of this article.

4 (3) If the Department, based on a recommendation of an Expert Review
5 Team, determines that a school’s low performance on assessments is, largely, due to
6 curricular problems, the school shall adopt the curriculum resources developed under this
7 section.

8 (4) Except as provided in paragraph (3) of this subsection, this section does
9 not require a public school or county board to adopt the Department’s curriculum standards
10 and curriculum resources and may not be construed to restrict a county board’s authority
11 to adopt curricula under § 4–111 of this article.

13 7–1401.

14 (a) In this subtitle the following words have the meanings indicated.

15 (b) “Quality online education standards” means the National Standards for
16 Quality Online Programs: Second Edition (2019).

17 (c) [“Sponsor” means the Department or a county school board, having a fiduciary
18 responsibility for the operation of the virtual school.

19 (d) “Virtual school” means a public school [established]:

20 (1) **ESTABLISHED** by [the Department or by] a county board **OR**
21 **MULTIPLE COUNTY BOARDS UNDER A WRITTEN AGREEMENT** under § 4–109 of this
22 article [in which the school];

23 (2) **THAT** uses [technology] **ONE OR MORE TECHNOLOGIES** to deliver [a
24 significant portion of] instruction to its students [via the Internet in a virtual or remote
25 setting] **ENTIRELY OR PRIMARILY ONLINE; AND**

26 (3) **IN WHICH THE STUDENTS AND INSTRUCTORS PARTICIPATE**
27 **REMOTELY FROM SEPARATE LOCATIONS.**

28 **7–1401.1.**

29 **THIS SUBTITLE DOES NOT APPLY TO:**

30 (1) **A VIRTUAL LEARNING OPPORTUNITY OFFERED BY THE**
31 **DEPARTMENT OR A COUNTY BOARD UNDER § 7–1002 OF THIS TITLE;**

1 **(2) AN UPPER-LEVEL HIGH SCHOOL PROGRAM THAT:**

2 **(I) HAS ONLINE COMPONENTS; AND**

3 **(II) DESIGNS A STUDENT'S ACADEMIC PROGRAM TO MAXIMIZE**
4 **THE FLEXIBILITY OF THE STUDENT'S SCHEDULE TO ACCOMMODATE THE STUDENT'S**
5 **WORK SCHEDULE; OR**

6 **(3) A PUBLIC SCHOOL OPERATING UNDER A VIRTUAL EDUCATION**
7 **PLAN DURING A PROLONGED STATE OF EMERGENCY UNDER SUBTITLE 14A OF THIS**
8 **TITLE.**

9 7-1402.

10 **(a) (1) [Subject] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
11 **SUBSECTION AND SUBJECT to the approval of the Department, a county board may**
12 **establish [a] ONE virtual school FOR THE ELEMENTARY, MIDDLE, AND HIGH SCHOOL**
13 **GRADE BANDS.**

14 **(2) THE DEPARTMENT MAY PROVIDE PRELIMINARY AUTHORIZATION**
15 **TO A COUNTY BOARD TO ESTABLISH ONE ADDITIONAL VIRTUAL SCHOOL ON A**
16 **SHOWING OF JUST CAUSE, AS DETERMINED BY THE DEPARTMENT.**

17 **(3) EACH VIRTUAL SCHOOL SHALL RECEIVE FINAL APPROVAL FROM**
18 **THE STATE BOARD.**

19 **(4) THE DEPARTMENT MAY REVOKE APPROVAL OF A VIRTUAL**
20 **SCHOOL, SUBJECT TO FINAL APPROVAL OF THE STATE BOARD, IF DURING THE**
21 **PREVIOUS SCHOOL YEAR THE VIRTUAL SCHOOL FAILS TO MEET THE STANDARDS**
22 **ESTABLISHED BY THE DEPARTMENT IN REGULATION.**

23 **(B) A VIRTUAL SCHOOL MAY NOT INCLUDE CLASSES FOR**
24 **PREKINDERGARTEN OR KINDERGARTEN STUDENTS.**

25 **[(b)] (C) A virtual school is subject to all applicable federal and State laws and**
26 **regulations governing the operation of a public school.**

27 **(D) EACH APPROVED VIRTUAL SCHOOL SHALL HAVE A SCHOOL**
28 **ACCOUNTABILITY CODE ASSIGNED BY THE DEPARTMENT.**

29 **(E) (1) A COUNTY BOARD MAY NOT CONTRACT WITH A FOR-PROFIT**
30 **ENTITY, BUT MAY CONTRACT WITH A NONPROFIT ENTITY, TO OPERATE OR**
31 **ADMINISTER A VIRTUAL SCHOOL FOR THE COUNTY BOARD.**

1 **(2) THE PROVISIONS OF PARAGRAPH (1) OF THIS SUBSECTION MAY**
2 **NOT BE CONSTRUED TO PROHIBIT A COUNTY BOARD FROM CONTRACTING WITH A**
3 **FOR-PROFIT ENTITY FOR GOODS AND SERVICES FOR A VIRTUAL SCHOOL.**

5 **[(c)] (A)** A student who is eligible for enrollment in a public school in the State
6 **[may] IS ELIGIBLE TO** enroll in a virtual school.

7 **(B) IN ADDITION TO THE CRITERIA ESTABLISHED BY THE DEPARTMENT OR**
8 **A COUNTY BOARD, AN APPLICATION FOR ENROLLMENT IN A VIRTUAL SCHOOL SHALL**
9 **REQUIRE AN APPLICANT TO DESCRIBE WHY INSTRUCTION IN A VIRTUAL LEARNING**
10 **ENVIRONMENT WILL LEAD TO SUCCESSFUL ACADEMIC OUTCOMES FOR THE**
11 **APPLICANT.**

12 **(C) (1) NOT MORE THAN 10% OF THE STUDENTS WHO WOULD OTHERWISE**
13 **ATTEND A SINGLE PUBLIC SCHOOL IN THE COUNTY IN ANY SCHOOL YEAR MAY**
14 **ENROLL IN A VIRTUAL SCHOOL ESTABLISHED BY A COUNTY BOARD.**

15 **(2) THE DEPARTMENT MAY AUTHORIZE A COUNTY BOARD TO EXCEED**
16 **THE CAP UNDER PARAGRAPH (1) OF THIS SUBSECTION ON A SHOWING OF JUST**
17 **CAUSE.**

18 **(D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, IF**
19 **A COUNTY BOARD RECEIVES MORE APPLICATIONS THAN THERE ARE AVAILABLE**
20 **SPACES IN A VIRTUAL SCHOOL, THE COUNTY BOARD SHALL ADMIT ALL STUDENTS**
21 **ON A LOTTERY BASIS.**

22 **(2) A COUNTY BOARD SHALL GIVE GREATER WEIGHT TO A STUDENT'S**
23 **LOTTERY STATUS AS A PART OF A LOTTERY HELD UNDER PARAGRAPH (1) OF THIS**
24 **SUBSECTION BASED ON DEMOGRAPHIC DIVERSITY UNDER SUBSECTION (E) OF THIS**
25 **SECTION AND ANY OTHER CRITERIA ESTABLISHED BY THE COUNTY BOARD.**

26 **(E) TO THE EXTENT PRACTICABLE, THE STUDENT BODY OF A VIRTUAL**
27 **SCHOOL SHALL REFLECT THE SOCIOECONOMIC, RACIAL, ETHNIC, CULTURAL, AND**
28 **GENDER DIVERSITY OF THE STUDENTS ENROLLED IN THE PUBLIC SCHOOL SYSTEM**
29 **IN THE COUNTY.**

30 **(F) THE COUNTY BOARD SHALL DEVELOP AN OUTREACH CAMPAIGN TO**
31 **PROVIDE INFORMATION TO THE PUBLIC ON THE AVAILABILITY OF THE VIRTUAL**
32 **SCHOOL OPTION.**

33 **[7-1403.] 7-1404.**

1 (a) A virtual school shall provide each enrolled student:

2 (1) Access to a sequential curriculum approved by the State Board that
3 meets or exceeds the standards adopted by the county board in the county of the virtual
4 school's principal place of business **OR THE COUNTY DESIGNATED UNDER A WRITTEN**
5 **AGREEMENT BETWEEN MULTIPLE COUNTY BOARDS;**

6 (2) The same length of time for learning opportunities per academic year
7 that is required for public school students, unless the virtual school can show that a student
8 has demonstrated mastery or completion of the subject area; [and]

9 (3) Regular assessment in the core areas of instruction as required by
10 regulations adopted by the State Board under [§ 7-1408] **§ 7-1409** of this subtitle; **AND**

11 (4) **ACCESS TO THE FOLLOWING SERVICES:**

12 (I) **TO THE EXTENT PRACTICABLE, EXTRACURRICULAR**
13 **ACTIVITIES AT THE PUBLIC SCHOOL THE STUDENT WOULD OTHERWISE BE**
14 **REQUIRED TO ATTEND;**

15 (II) **NOTWITHSTANDING ANY OTHER LAW OR REGULATION AND**
16 **SUBJECT TO A PARTICIPATION AGREEMENT BETWEEN THE PUBLIC SCHOOL AND**
17 **THE PARENT OR GUARDIAN OF THE STUDENT, PARTICIPATION IN ORGANIZED**
18 **ATHLETICS AND ON ATHLETIC TEAMS AT THE PUBLIC SCHOOL THE STUDENT WOULD**
19 **OTHERWISE BE REQUIRED TO ATTEND;**

20 (III) **WRAPAROUND SERVICES;**

21 (IV) **FOOD AND NUTRITION SERVICES; AND**

22 (V) **HEALTH CARE SERVICES EQUIVALENT TO SERVICES**
23 **AVAILABLE TO STUDENTS WHO RECEIVE IN-PERSON INSTRUCTION IN THE PUBLIC**
24 **SCHOOLS IN THE COUNTY.**

25 (b) A curriculum adopted under subsection (a) of this section shall have [an]:
