Environment – Tidal Wetlands – Pier Platforms

- 3 FOR the purpose of prohibiting the total area of certain fixed pier platforms and floating 4 pier platforms in tidal wetlands from exceeding a certain square footage per pier; 5 prohibiting the Department of the Environment from requiring a person to obtain a 6 license or permit for the construction or installation of a floating pier platform under 7 certain circumstances; prohibiting a floating pier platform from exceeding a certain 8 size or being located in a certain area; requiring a person that authorizes the 9 construction or installation of a floating pier platform to hire a licensed marine 10 contractor to perform the work; requiring a person that undertakes the construction 11 or installation of a floating pier platform to be a licensed marine contractor; requiring 12 that a floating pier platform be considered a boat slip; and generally relating to pier 13 platforms in tidal wetlands.

- 2 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 3 That the Laws of Maryland read as follows:
- 4 Article Environment
- 5 16–101.
- 6 (a) In this title the following words have the meanings indicated.
- 7 (b) "Board" means the Board of Public Works.
- 8 (j) "Person" means any natural person, partnership, joint-stock company, 9 unincorporated association or society, the federal government, the State, any unit of the State, a political subdivision, or other corporation of any type.
- 11 (k) (1) "Pier" means any pier, wharf, dock, walkway, bulkhead, breakwater, 12 piles, or other similar structure.
- 13 (2) "Pier" does not include any structure on pilings or stilts that was originally constructed beyond the landward boundaries of State or private wetlands.
- 15 (l) (1) "Private wetlands" means any land not considered "State wetland" 16 bordering on or lying beneath tidal waters, which is subject to regular or periodic tidal 17 action and supports aquatic growth.
- 18 (2) "Private wetlands" includes wetlands, transferred by the State by a valid grant, lease, patent, or grant confirmed by Article 5 of the Maryland Declaration of Rights, to the extent of the interest transferred.
- 21 (p) (1) "State wetlands" means any land under the navigable waters of the 22 State below the mean high tide, affected by the regular rise and fall of the tide. [Wetlands of this category which]
- 24 (2) "STATE WETLANDS" DOES NOT INCLUDE LAND UNDER THE
 25 NAVIGABLE WATERS OF THE STATE BELOW THE MEAN HIGH TIDE, AFFECTED BY THE
 26 REGULAR RISE AND FALL OF THE TIDE, THAT have been transferred by the State by
 27 valid grant, lease, patent, or grant confirmed by Article 5 of the Maryland Declaration of
 28 Rights [shall be considered "private wetland"] to the extent of the interest transferred.
- (Q) "TIDAL WETLANDS" MEANS ALL STATE AND PRIVATE WETLANDS,
 MARSHES, SUBMERGED AQUATIC VEGETATION, LANDS, AND OPEN WATER WITHIN
 THE CHESAPEAKE BAY AND ITS TIDAL TRIBUTARIES, THE COASTAL BAYS AND
 THEIR TIDAL TRIBUTARIES, AND THE ATLANTIC OCEAN OUT TO A DISTANCE OF 3
 MILES OFFSHORE OF THE LOW WATER MARK.

- 2 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 3 INDICATED.
- 4 (2) "FIXED PIER PLATFORM" MEANS A WATER-DEPENDENT
- 5 STRUCTURE ATTACHED TO PILINGS CONSTRUCTED ON OR OVER TIDAL WETLANDS
- 6 FOR THE PURPOSE OF GAINING ACCESS TO THE NAVIGABLE WATERS OF THE STATE.
- 7 (3) "FLOATING PIER PLATFORM" MEANS A FLOATING
- 8 WATER-DEPENDENT STRUCTURE CONSTRUCTED OR INSTALLED ON OR OVER TIDAL
- 9 WETLANDS FOR THE PURPOSE OF GAINING ACCESS TO THE NAVIGABLE WATERS OF
- 10 THE STATE.
- 11 (4) "LICENSE" MEANS A WRITTEN AUTHORIZATION BY THE BOARD OR
- 12 BY THE DEPARTMENT UNDER DELEGATION FROM THE BOARD TO CONSTRUCT OR
- 13 INSTALL STRUCTURES ON OR OVER TIDAL WETLANDS.
- 14 (5) "PERMIT" MEANS A WRITTEN AUTHORIZATION BY THE
- 15 DEPARTMENT TO CONSTRUCT OR INSTALL STRUCTURES ON OR OVER TIDAL
- 16 WETLANDS.
- 17 (B) THIS SECTION APPLIES ONLY TO PRIVATE NONCOMMERCIAL PIERS IN
- 18 TIDAL WETLANDS.
- 19 (C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION
- 20 AND SUBJECT TO SUBSECTION (D)(2) OF THIS SECTION, THE TOTAL AREA OF FIXED
- 21 PIER PLATFORMS AND FLOATING PIER PLATFORMS MAY NOT EXCEED 400 SQUARE
- 22 FEET PER PIER.
- 23 (2) THE LIMITATION UNDER PARAGRAPH (1) OF THIS SUBSECTION
- 24 DOES NOT APPLY TO THE REPLACEMENT OF AN EXISTING PIER WITH A PIER THAT:
- 25 (I) IS COMPARABLE IN SIZE TO THE EXISTING PIER, AS
- 26 DETERMINED BY THE BOARD OR THE DEPARTMENT; AND
- 27 (II) DOES NOT INCREASE THE TOTAL AREA OF ANY FIXED PIER
- 28 PLATFORM OR FLOATING PIER PLATFORM ASSOCIATED WITH THE EXISTING PIER.
- 29 (D) (1) THE DEPARTMENT MAY NOT REQUIRE A PERSON TO OBTAIN A
- 30 LICENSE OR PERMIT FOR THE CONSTRUCTION OR INSTALLATION OF A FLOATING
- 31 PIER PLATFORM IF THE FLOATING PIER PLATFORM, AND THE CONSTRUCTION OR

- 7 (II) BE LOCATED OVER VEGETATED TIDAL WETLANDS,
- 8 INCLUDING SUBMERGED AQUATIC VEGETATION.

- 10 THAT AUTHORIZES THE CONSTRUCTION OR INSTALLATION OF A FLOATING PIER
- 11 PLATFORM SHALL HIRE A LICENSED MARINE CONTRACTOR TO PERFORM THE WORK.
- 12 (II) NOTWITHSTANDING § 16–106 OF THIS SUBTITLE, A PERSON
- 13 THAT UNDERTAKES THE CONSTRUCTION OR INSTALLATION OF A FLOATING PIER
- 14 PLATFORM SHALL BE A LICENSED MARINE CONTRACTOR.
- 15 (4) A FLOATING PIER PLATFORM SHALL BE CONSIDERED A BOAT
- 16 SLIP.
- 17 (E) THE DEPARTMENT SHALL ADOPT REGULATIONS TO IMPLEMENT THIS
- 18 SECTION.
- 19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 20 October 1, 2023.
