 Professionals; clarifying and altering the distribution of certain fees and penalties;
 clarifying the application of certain license requirements and penalties; and
 generally relating to the regulation of on–site wastewater services.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 18 That the Laws of Maryland read as follows:

2 (a) In this section, "license holder" means an individual who holds a valid on-site 3 wastewater property transfer inspection license issued by the Department under this 4 section.

5 (b) This section does not apply to an individual who inspects an on-site sewage 6 disposal system as a part of the individual's duties as an employee of the federal 7 government, the State, or any local government of the State.

8 (c) On or after July 1, 2022, an individual may not engage in the business of 9 inspecting an on-site sewage disposal system FOR THE PURPOSE OF PROPERTY 10 TRANSFER unless the individual holds a valid on-site wastewater property transfer 11 inspection license issued by the Department.

12 (d) (1) On or before January 1, 2022, the Department shall adopt regulations 13 establishing eligibility criteria, minimum training standards for on-site wastewater 14 property transfer inspection licenses, the frequency with which licenses must be renewed, 15 and the fees for license applications and renewals.

(2) The regulations adopted under this subsection shall require that:

17 (i) The training include instruction on determining whether an 18 on-site sewage disposal system is:

1. In need of replacement or repair; and

202.Not in compliance with statutory or regulatory21 requirements; and

22 (ii) Each inspection performed by a license holder follows the 23 inspection format provided by the Department.

AND BE IT FURTHER ENACTED, That this Act is an emergency 3 measure, is necessary for the immediate preservation of the public health or safety, has 4 been passed by a yea and nay vote supported by three—fifths of all the members elected to 5 each of the two Houses of the General Assembly, and shall take effect from the date it is 6 enacted.
