BY repealing and reenacting, with amendments. Article – Natural Resources Section 1–403.1 Annotated Code of Maryland (2018 Replacement Volume and 2022 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Natural Resources 1-403.1.**(1)** The EXCEPT AS PROVIDED UNDER PARAGRAPH (2) OF THIS (a) SUBSECTION, THE Department shall make available and, on request, issue any license

AND BE IT FURTHER ENACTED, That, if the Department of Natural Resources cannot issue certain licenses, stamps, permits, registrations, or certificates in a digital or electronic format because of federal restrictions, it is the intent of the General Assembly that the Department shall issue those licenses, stamps, permits, registrations or certificates in a digital or electronic format whenever the federal government eliminates those restrictions.
