A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Speed Limits – School Zones**

3 FOR the purpose of altering the radius around certain schools within which a school zone
4 may be established and speed monitoring systems may be placed and used; and
5 generally relating to the enforcement of speed limits in school zones.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Transportation**

19 21–803.1.

20 (a) (1) Subject to subsection (f) of this section, within a [half-mile]
21 **0.1-MILE** radius of any school, the State Highway Administration or a local authority:

1 (i) May establish a school zone and maximum speed limits
2 applicable in the school zone; and

3 (ii) Subject to subsection (d) of this section, may provide that fines
4 are to be doubled for speeding violations within the school zone.

5 (2) (i) The State Highway Administration may establish a school zone
6 under paragraph (1) of this subsection on any State highway or, at the request of a local
7 authority, on any highway under the jurisdiction of the local authority.

8 (ii) A local authority may establish a school zone under paragraph
9 (1) of this subsection on any highway under its jurisdiction.

10 (iii) In Prince George's County, a municipal corporation may
11 establish a school zone under paragraph (1) of this subsection on any highway that:

12 1. Is not under State jurisdiction; and

13 2. Is located within the corporate limits of the municipal
14 corporation.

15 (b) (1) On each highway where a school zone is established under this section,
16 in accordance with specifications of the State Highway Administration, the State Highway
17 Administration or local authority:

18 (i) Shall place signs designating the school zone; and

19 (ii) May place other traffic control devices, including timed flashing
20 warning lights.

21 (2) The signs designating a school zone shall indicate the maximum speed
22 limit applicable in the school zone.

23 (3) The local authority shall pay the State Highway Administration the
24 cost of placing and maintaining signs and other traffic control devices on highways under
25 the jurisdiction of the local authority when the State Highway Administration establishes
26 the school zone at the local authority's request.

27 (4) In Prince George's County, a municipal corporation shall be responsible
28 for the cost of placing and maintaining signs and other traffic control devices for a school
29 zone that the municipal corporation establishes on a highway within its corporate limits.

30 (c) A maximum speed limit in a school zone established under this section is in
31 effect when posted on appropriate signs giving notice of the limit.

1 (d) The fines for speeding in a school zone are double the amount that would
2 otherwise apply if, in accordance with specifications adopted by the State Highway
3 Administration:

4 (1) (i) A sign designating a school zone under this section is equipped
5 with timed flashing warning lights and indicates that fines for speeding are doubled when
6 the lights are activated; and

7 (ii) The lights are activated at the time the violation occurs; or

8 (2) A sign designating a school zone under this section indicates that fines
9 for speeding are doubled during school hours.

10 (e) A person may not drive a motor vehicle at a speed exceeding the posted speed
11 limit within a school zone established in accordance with subsection (d) of this section.

12 (f) In any school zone where a school crossing guard is posted to assist students
13 in crossing a highway, the maximum speed limit may not exceed 35 miles per hour in the
14 school zone during the hours posted on signs designating the school zone.

15 (g) A person convicted of a violation of subsection (e) of this section is subject to a
16 fine not exceeding \$1,000.

18 (a) (1) In this section the following words have the meanings indicated.

19 (7) “School zone” means a designated roadway segment within up to a
20 [half-mile] **0.1-MILE** radius of a school for any of grades kindergarten through grade 12
21 where school-related activity occurs, including:

22 (i) Travel by students to or from school on foot or by bicycle; or

23 (ii) The dropping off or picking up of students by school buses or
24 other vehicles.

25 (8) “Speed monitoring system” means a device with one or more motor
26 vehicle sensors producing recorded images of motor vehicles traveling at speeds at least 12
27 miles per hour above the posted speed limit.

28 (b) (1) (vi) This section applies to a violation of this subtitle recorded by a
29 speed monitoring system that meets the requirements of this subsection and has been
30 placed:

31 2. In a school zone with a posted speed limit of at least 20
32 miles per hour;

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
2 1, 2023.
