# FOR the purpose of altering the educational requirements that individuals must meet to be licensed as clinical or graduate alcohol and drug counselors; and generally relating to clinical and graduate alcohol and drug counselors.

## SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
