AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that the requirement for publication of documents, testimony from the public, and other materials in advance of an open meeting in accordance with § 3–307 of the General Provisions Article[, as enacted by Section 1 of this Act,] may not be construed to:
23 24	(1) limit the discussions and deliberations of the public body to matters referenced in the materials published prior to the meeting; or
25 26	(2) require the disclosure of documents or material that would be exempt from public inspection under Title 4 of the General Provisions Article.
