CHAPTER _____

1 AN ACT concerning

2 **Property Tax Credit – Public Safety Officer**

3 FOR the purpose of repealing the definition of “public safety officer” for purposes of a
4 certain credit against the county or municipal corporation property tax imposed on
5 a dwelling owned by a public safety officer; repealing a certain limitation on the
6 amount of the credit; requiring the governing body of a county or municipal
7 corporation that authorizes the credit to establish, by law, the definition of “public
8 safety officer” for purposes of eligibility for the credit; and generally relating to a
9 property tax credit for public safety officers.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Tax – Property**

18 9–260.

1 (a) [(1)] In this section [the following words have the meanings indicated.

2 (2) “Dwelling”, “DWELLING” has the meaning stated in § 9–105 of this
3 title.

4 [(3) “Public safety officer” means:

5 (i) a firefighter, an emergency medical technician, a correctional
6 officer, a police officer, or a deputy sheriff employed full time by a public safety agency in
7 the county or municipal corporation where the individual resides;

8 (ii) a volunteer firefighter or a volunteer emergency medical
9 technician for a public safety agency in the county or municipal corporation where the
10 individual resides;

11 (iii) a park police officer employed full time by the
12 Maryland–National Capital Park and Planning Commission who resides in Montgomery
13 County or Prince George’s County; or

14 (iv) a police officer employed full time by the Washington Suburban
15 Sanitary Commission who resides in Montgomery County or Prince George’s County.]

16 (b) The governing body of a county or municipal corporation may grant, by law, a
17 property tax credit under this section against the county or municipal corporation property
18 tax imposed on a dwelling located in the county or municipal corporation that is owned by
19 a public safety officer if the public safety officer is otherwise eligible for the credit
20 authorized under § 9–105 of this title.

21 [(c) In any taxable year, the credit under this section may not exceed the lesser of:

22 (1) \$2,500 per dwelling; or

23 (2) the amount of property tax imposed on the dwelling.]

24 [(d)] (C) The governing body of a county or a municipal corporation:

25 (1) SHALL DEFINE, BY LAW, “PUBLIC SAFETY OFFICER” FOR
26 PURPOSES OF ELIGIBILITY FOR THE CREDIT UNDER THIS SECTION; AND

27 (2) may establish, by law:

28 [(1)] (I) [subject to subsection (c) of this section,] the amount of the credit
29 under this section;

30 [(2)] (II) the duration of the credit;

1 [(3)] (III) additional eligibility requirements for public safety officers to
2 qualify for the credit;

3 [(4)] (IV) procedures for the application and uniform processing of
4 requests for the credit; and

5 [(5)] (V) any other provisions necessary to carry out this section.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
7 1, 2023, and shall be applicable to all taxable years beginning after June 30, 2023.
