1 AN ACT concerning

Natural Resources – Apprentice Hunting License – Alterations

- FOR the purpose of authorizing the Department of Natural Resources to issue an apprentice
 hunting license to a person under a certain age who has previously been issued an
 apprentice hunting license under certain circumstances; and generally relating to the
 apprentice hunting license.

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

2 (d) A person who wishes to obtain a hunting license shall complete and submit an 3 application to the Department or to any person designated by the Department to issue a 4 hunting license.

5 (e) An applicant for a license issued under this section shall provide all the 6 information required by the Department, including the last four digits of the applicant's 7 Social Security number, if the applicant has a Social Security number.

8 (f) Before a hunting license may be issued the applicant for the license shall 9 acknowledge, as a component of the application, that a hunting license does not of itself 10 permit an individual to hunt on private property.

11 (g) (1) (I) There shall be the following types of hunting licenses in the 12 State[:].

13 [(i)] (II) 1. [A] THERE IS A resident hunting license that 14 enables the purchaser to hunt all legal game birds and mammals during any appropriate 15 season in Maryland without the purchase of additional stamps, unless the purchaser is 16 hunting migratory game birds or deer during bow and arrow season or black powder season.

17 **2.** To hunt migratory game birds the purchaser must also buy 18 a Maryland migratory game bird stamp and to hunt wild waterfowl the purchaser must buy 19 both a Maryland migratory game bird stamp and a federal migratory bird hunting and 20 conservation stamp.

21 3. To hunt deer during bow and arrow season and black
22 powder season the purchaser must also purchase a bow and arrow or black powder stamp.

[(ii)] (III) 1. [A] THERE IS A nonresident hunting license that enables the purchaser to hunt all legal game birds and mammals during any appropriate season without the purchase of additional stamps unless the purchaser is hunting migratory game birds or deer during bow and arrow season or black powder season.

27 **2.** This license enables the purchaser to hunt migratory game 28 birds only with the purchase of a Maryland migratory game bird stamp and to hunt wild 29 waterfowl only with the purchase of both a Maryland migratory game bird stamp and a 30 federal migratory bird hunting and conservation stamp.

31 **3.** This license enables the purchaser to hunt deer during bow 32 and arrow season and black powder season only with the purchase of a nonresident bow and 33 arrow or black powder stamp.

34 [(iii)] (IV) 1. [A] THERE IS A nonresident 3-day hunting license 35 that enables the purchaser to hunt all legal game birds and mammals except deer and

1 turkey for the 3 consecutive legal hunting days in a single season that are specified on the 2 license by the issuing agent.

3 2. The purchaser must also purchase a Maryland migratory 4 game bird stamp to hunt migratory game birds and a federal migratory bird hunting and 5 conservation stamp to hunt wild waterfowl with this license.

6 **3.** Under no circumstance does this license authorize the 7 purchaser to hunt deer and turkey.

8 [(iv)] (V) 1. A. [An] THERE IS AN apprentice hunting 9 license that enables the purchaser to hunt all legal game birds and mammals in a single 10 season without the purchase of additional stamps unless the purchaser is hunting migratory 11 game birds or deer during bow and arrow season or black powder season.

B. This license enables the purchaser to hunt migratory game birds only with the purchase of a Maryland migratory game bird stamp and to hunt wild waterfowl only with the purchase of both a Maryland migratory game bird stamp and a federal migratory bird hunting and conservation stamp.

16 **C.** This license enables the purchaser to hunt deer during bow 17 and arrow season and black powder season only with the purchase of a bow and arrow or 18 black powder stamp.

19 2. A. A person may obtain an apprentice hunting license
 20 on satisfactory completion of a short online or electronic course of instruction in competency
 21 in firearms and hunter safety approved by the Department.

B. A person may hunt under an apprentice hunting license only if accompanied and directly supervised by another person who is at least 18 years of age and possesses a valid resident nonapprentice hunting license issued under this subtitle.

C. A person who accompanies and directly supervises an apprentice hunting licensee shall maintain close visual and verbal contact with, provide adequate direction to, and be in a position to immediately assume control of the firearm of the apprentice hunting licensee.

29 3. Except for a person participating in a junior hunt approved 30 by the Department, an apprentice hunting licensee who has obtained a certificate of 31 competency in firearms and hunter safety under § 10–301.1 of this subtitle may hunt 32 without supervision.

4. [An] EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 5
 OF THIS SUBPARAGRAPH, AN apprentice hunting license:

A. May be issued to a person only once in the person's lifetime;

NOTWITHSTANDING SUBSUBPARAGRAPH 4 OF THIS SUBPARAGRAPH, THE DEPARTMENT MAY ISSUE AN APPRENTICE HUNTING $\mathbf{5}$ 6 LICENSE TO A PERSON UNDER THE AGE OF 17 YEARS WHO HAS PREVIOUSLY BEEN 7 **ISSUED AN APPRENTICE HUNTING LICENSE.** 8 Β. THE DEPARTMENT SHALL REQUIRE AN APPLICANT 9 FOR A SECOND OR SUBSEQUENT APPRENTICE HUNTING LICENSE UNDER THIS SUBSUBPARAGRAPH TO REPEAT THE COURSE OF INSTRUCTION IN COMPETENCY IN 1011 FIREARMS AND HUNTER SAFETY SPECIFIED UNDER SUBSUBPARAGRAPH 2A OF THIS 12 SUBPARAGRAPH.
