BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Criminal Law **[**3–318. Except as provided in subsections (b) and (c) of this section, a person may not be prosecuted under § 3–303, § 3–304, § 3–307, or § 3–308 of this subtitle for a crime against a victim who was the person's legal spouse at the time of the alleged rape or sexual offense. (b) A person may be prosecuted under  $\S 3-303(a), \S 3-304(a)(1), \text{ or } \S 3-307(a)(1)$
