A BILL ENTITLED

1 AN ACT concerning

State Police Retirement System and Law Enforcement Officers' Pension System Deferred Retirement Option Program - Alterations

- 4 FOR the purpose of increasing the maximum number of years of eligibility service that 5 certain members of the State Police Retirement System or Law Enforcement Officers' 6 Pension System may have to participate in the Deferred Retirement Option Program 7 (DROP); increasing the number of years that certain members of the State Police 8 Retirement System or Law Enforcement Officers' Pension System may participate 9 in the DROP; authorizing certain individuals, subject to certain limitations and requirements, to elect to extend their participation in the DROP; and generally 10 relating to certain members of the State Police Retirement System or Law 11 12 Enforcement Officers' Pension System and the Deferred Retirement Option 13 Program.



AND BE IT FURTHER ENACTED, That: Section 1 of this Act applies to any individual who began participation in the 7 (a) 8 Deferred Retirement Option Program (DROP) under §§ 24–401.1 or 26–401.1 of the State 9 Personnel and Pensions Article before July 1, 2023, and continues to participate in the 10 DROP on or after July 1, 2023. 11 (b) Except as provided in paragraph (2) of this subsection, an individual 12 described in subsection (a) of this section may elect to extend participation in the DROP by 13 the lesser of: 14 the difference between 7 years and the number of years the (i) 15 individual elected to participate in the DROP at the time the individual joined the DROP; 16 or 17 the difference between 32 years of eligibility service and the total (ii) 18 amount of eligibility service the individual had accrued at the time the individual joined 19 the DROP. 20 An individual may not elect to extend participation in the DROP by a 21number of years that will result in the individual terminating the DROP at an age older 22than age 60. 23An individual who elects to extend participation in the DROP shall do (1) so on or before December 31, 2023, by completing a form provided by the Board of Trustees 24for the State Retirement and Pension System. 2526 The form submitted by the individual in paragraph (1) of this 27 subsection shall include a signed acknowledgment by: 28 for a member of the State Police Retirement System, the (i) 29 individual's Director of Human Resources within the Department of State Police that the 30 individual's employment with the Department of State Police and participation in the 31 DROP will be extended by the time period specified on that form; or
