- 4 FOR the purpose of increasing the maximum number of years of eligibility service that 5 certain members of the State Police Retirement System or Law Enforcement Officers' 6 Pension System may have to participate in the Deferred Retirement Option Program (DROP); increasing the number of years that certain members of the State Police 7 8 Retirement System or Law Enforcement Officers' Pension System may participate 9 in the DROP; authorizing certain individuals, subject to certain limitations and 10 requirements, to elect to extend their participation in the DROP; and generally 11 relating to certain members of the State Police Retirement System or Law 12 Enforcement Officers' Pension System and the Deferred Retirement Option 13 Program.

3 4	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

7	(a) (1) In this section the following words have the meanings indicated.
8 9	(2) "DROP" means the Deferred Retirement Option Program established under this section.


