A BILL ENTITLED

1 AN ACT concerning

2 **Street Racing and Exhibition Driving – Prohibited Acts, Enforcement, and**
3 **Penalties**

4 FOR the purpose of altering certain penalties and the points assessments for certain motor
5 vehicle violations related to participation in a race or speed contest; prohibiting a
6 person from engaging in exhibition driving on any highway or private property that
7 is used for driving by the public; authorizing the towing and impounding of a vehicle
8 involved in certain motor vehicle violations related to participation in a race or speed
9 contest or engaging in exhibition driving; and generally relating to prohibited acts
10 and penalties related to participation in a race or speed contest or engaging in
11 exhibition driving.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 12 That Section(s) 16–402(a)(22) of Article – Transportation of the Annotated Code of
 13 Maryland be repealed.

14 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 16–402(a)(23)
 15 through (33) and (34) through (43) and 21–101(k) through (z) of Article – Transportation of
 16 the Annotated Code of Maryland be renumbered to be Section(s)
 17 16–402(a)(22) through (32) and (35) through (44) and 21–101(l) through (aa), respectively.

18 SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 19 as follows:

20 **Article – Transportation**

22 (a) After the conviction of an individual for a violation of Title 2, Subtitle 5, §
 23 2–209, § 3–211, or § 10–110 of the Criminal Law Article, or of the vehicle laws or regulations
 24 of this State or of any local authority, points shall be assessed against the individual as of
 25 the date of violation and as follows:

26 **(33) EXCEPT AS PROVIDED IN ITEM (45) OF THIS SUBSECTION,**
 27 **PARTICIPATING IN A RACE OR SPEED CONTEST ON A HIGHWAY.....8 POINTS**

28 **(34) EXCEPT AS PROVIDED IN ITEM (46) OF THIS SUBSECTION,**
 29 **ENGAGING IN EXHIBITION DRIVING ON A HIGHWAY.....8 POINTS**

30 **(45) PARTICIPATING IN A RACE OR SPEED CONTEST ON A HIGHWAY**
 31 **RESULTING IN SERIOUS BODILY INJURY, AS DEFINED IN § 20–102(C) OF THIS**
 32 **ARTICLE, OR DEATH TO ANOTHER PERSON.....12 POINTS**

1 (46) ENGAGING IN EXHIBITION DRIVING ON A HIGHWAY RESULTING IN
2 SERIOUS BODILY INJURY, AS DEFINED IN § 20-102(C) OF THIS ARTICLE, OR DEATH
3 TO ANOTHER PERSON.....12 POINTS

5 (a) In this title and Title 25 of this article the following words have the meanings
6 indicated.

7 (K) "EXHIBITION DRIVING" MEANS:

8 (1) THE OPERATION OF A MOTOR VEHICLE IN A MANNER THAT
9 RESULTS IN:

10 (I) THE EXCESSIVE, ABRUPT ACCELERATION OR
11 DECELERATION OF THE MOTOR VEHICLE;

12 (II) THE SKIDDING, SQUEALING, BURNING, OR SMOKING OF THE
13 TIRES OF THE MOTOR VEHICLE;

14 (III) THE SWERVING OR SWAYING OF THE MOTOR VEHICLE FROM
15 SIDE TO SIDE WHILE SKIDDING;

16 (IV) THE ENGINE OF THE MOTOR VEHICLE PRODUCING AN
17 UNREASONABLY LOUD, RAUCOUS, OR DISTURBING NOISE;

18 (V) THE GRINDING OF THE GEARS OF THE MOTOR VEHICLE OR
19 THE BACKFIRING OF THE ENGINE OF THE MOTOR VEHICLE; OR

20 (VI) ANY OF THE WHEELS OF THE MOTOR VEHICLE LOSING
21 CONTACT WITH THE GROUND; OR

22 (2) THE TRANSPORTATION OF A PASSENGER ON OR IN AN AREA OF A
23 MOTOR VEHICLE THAT IS NOT DESIGNED OR INTENDED FOR PASSENGER
24 TRANSPORT, SUCH AS THE HOOD OR ROOF.

26 (a) (1) Except as provided in § 21-1211 of this title, on any highway or on any
27 private property that is used by the public in general, a person may not drive a vehicle in a
28 race or speed contest, whether or not on a wager or for a prize or reward.

29 [(b)] (2) Except as provided in § 21-1211 of this title, a person may not
30 participate as a timekeeper or flagman in any race or speed contest specified in [subsection
31 (a) of this section] PARAGRAPH (1) OF THIS SUBSECTION.

1 **(B) A POLICE OFFICER MAY ORDER THE TOWING AND IMPOUNDING OF A**
2 **VEHICLE THAT IS THE SUBJECT OF A VIOLATION OF SUBSECTION (A)(1) OF THIS**
3 **SECTION.**

4 **(C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**
5 **PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT TO**
6 **IMPRISONMENT NOT EXCEEDING 60 DAYS OR A FINE NOT EXCEEDING \$1,000 OR**
7 **BOTH.**

8 **[(c)] (2) A person convicted of a violation of subsection [(a)] (A)(1) of this section**
9 **that results in serious bodily injury [to another person], as defined in § 20–102(c) of this**
10 **article, TO, OR THE DEATH OF, ANOTHER PERSON is subject to imprisonment not**
11 **exceeding 1 year or a fine not exceeding \$1,000 or both.**

13 **(A) ON ANY HIGHWAY OR ON ANY PRIVATE PROPERTY THAT IS USED FOR**
14 **DRIVING BY THE PUBLIC IN GENERAL, A PERSON MAY NOT ENGAGE IN EXHIBITION**
15 **DRIVING.**

16 **(B) A POLICE OFFICER MAY ORDER THE TOWING AND IMPOUNDING OF A**
17 **VEHICLE THAT IS THE SUBJECT OF A VIOLATION OF THIS SECTION.**

18 **(C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**
19 **PERSON CONVICTED OF A VIOLATION OF THIS SECTION IS SUBJECT TO**
20 **IMPRISONMENT NOT EXCEEDING 60 DAYS OR A FINE NOT EXCEEDING \$1,000 OR**
21 **BOTH.**

22 **(2) A PERSON CONVICTED OF A VIOLATION OF THIS SECTION THAT**
23 **RESULTS IN SERIOUS BODILY INJURY, AS DEFINED IN §**
24 **20–102(C) OF THIS ARTICLE, TO, OR THE DEATH OF, ANOTHER PERSON IS SUBJECT**
25 **TO IMPRISONMENT NOT EXCEEDING 1 YEAR OR A FINE NOT EXCEEDING \$1,000 OR**
26 **BOTH.**
