2 Pesticide Registration Pesticides – PFAS Testing – Requirements Study

3 FOR the purpose of prohibiting, beginning on a certain date, the Secretary of Agriculture from registering a pesticide for use against mosquitoes in the State unless the 4 distributor of the pesticide submits to the Department of Agriculture certain test $\mathbf{5}$ 6 results and a certain affidavit; prohibiting, beginning on a certain date, the Secretary 7 from registering a pesticide for use in the State unless the distributor of the pesticide 8 submits to the Department certain test results and a certain affidavit; and generally relating to the registration of pesticides in the State requiring the Department of 9 10 Agriculture, in consultation with certain State and federal agencies, to study the use 11 of perfluoroalkyl and polyfluoroalkyl substances (PFAS) in pesticides in the State; requiring the Department to report certain findings and recommendations to the 12 Governor and certain committees of the General Assembly on or before a certain 13date; and generally relating to the use of PFAS in pesticides in the State. 14

8 (c) On or before November 1, 2023, the Department of Agriculture shall report its 9 findings and recommendations to the Governor and, in accordance with § 2–1257 of the 10 State Government Article, to the Senate Committee on Education, Energy, and the 11 Environment and the House Health and Government Operations Committee.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October June 1, 2023.
