- 3 FOR the purpose of requiring a motor vehicle rental company to provide with each rental 4 vehicle a spare tire and tire repair tools if these items were included with the initial 5 sale of the rental vehicle or are generally included in new vehicles of the year, make, 6 model, and style of the rental vehicle; requiring a motor vehicle rental company to 7 disclose in the rental agreement that the rental vehicle is not equipped with a spare 8 tire or tire repair tools under certain circumstances; requiring a motor vehicle rental 9 company to require a renter to initial the disclosure before renting the rental vehicle; and generally relating to the provision of spare tires and tire repair tools for rental 10 11 vehicles.

(a) (1) 2 "Motor vehicle rental company" means a person that is in the business (3)3 of providing motor vehicles to the public under a rental agreement for a period not exceeding 180 days. 4 "Rental agreement" means a written agreement containing the terms 5 (4) 6 and conditions that govern the use of a rental vehicle provided by a motor vehicle rental 7 company under the provisions of this article. 18–110. 8 9 **(1)** IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS (A) 10 INDICATED. 11 "MOTOR VEHICLE RENTAL COMPANY" HAS THE MEANING STATED 12 IN § 17–104.3 OF THIS ARTICLE. "RENTAL AGREEMENT" HAS THE MEANING STATED IN § 17-104.3 13 **(3)** OF THIS ARTICLE. 14 "TIRE REPAIR TOOLS" INCLUDES: **(4)** 15 16 (I)A VEHICLE JACK; 17 (II) A TIRE IRON; 18 (III) A PORTABLE TIRE INFLATOR; AND 19 (IV) WHEEL WEDGES. 20 (B) THIS SECTION APPLIES ONLY TO A RENTAL VEHICLE REGISTERED 21UNDER § 13–912 OR § 13–937 OF THIS ARTICLE. 22(C) A MOTOR VEHICLE RENTAL COMPANY SHALL: 23 **(1)** PROVIDE WITH EACH RENTAL VEHICLE A SPARE TIRE AND TIRE 24REPAIR TOOLS, IF THESE ITEMS WERE INCLUDED WITH THE INITIAL SALE OF THE 25RENTAL VEHICLE OR ARE GENERALLY INCLUDED IN NEW VEHICLES OF THE YEAR, 26 MAKE, MODEL, AND STYLE OF THE RENTAL VEHICLE; OR 27 **(2)** IF A SPARE TIRE OR TIRE REPAIR TOOLS ARE NOT PROVIDED:

DISCLOSE IN THE RENTAL AGREEMENT THAT THE RENTAL

- 1 VEHICLE IS NOT EQUIPPED WITH A SPARE TIRE OR TIRE REPAIR TOOLS; AND
- 2 (II) REQUIRE A RENTER TO INITIAL THE DISCLOSURE BEFORE
- 3 RENTING THE RENTAL VEHICLE.
- 4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 5 October 1, 2023.
