FOR the purpose of altering the definition of "massage therapy"; repealing a provision of 4 law that provides that certain provisions of law do not require a nonprofit health insurance plan, an insurer, a health maintenance organization, or a person acting as a third party administrator to reimburse a licensed massage therapist or registered massage practitioner for any services rendered; and generally relating to the regulation of massage therapists and massage practitioners.

- 2 (a) In this title the following words have the meanings indicated.
- 3 (f) (3) "Massage therapy" does not include:
- 4 (i) The diagnosis [or treatment] of illness, disease, or injury;
- 5 (ii) The adjustment, manipulation, or mobilization of any of the 6 articulations of the osseous structures of the human body or spine; or
- 7 (iii) Except as provided in paragraph (2) of this subsection, the laying 8 on of hands, consisting of pressure or movement on an individual who is fully clothed, 9 except for footwear, to specifically affect the electromagnetic energy or energetic field of the 10 human body.

- This subtitle does not require a nonprofit health service plan, an insurer, a health maintenance organization, or a person acting as a third party administrator to reimburse a licensed massage therapist or registered massage practitioner for any services rendered even though the services are within the scope of practice of the licensed massage therapist or registered massage practitioner.]
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023.
