Environment - Climate Crisis Plan - Requirement

FOR the purpose of requiring each county to prepare a climate crisis plan to address the effects of climate change in the county; requiring each county to submit its plan to the Department of the Environment for review and feedback on or before a certain date; requiring the Department to provide feedback to each county on or before a certain date; requiring each county to finalize its plan on or before a certain date; requiring each county to review and update its plan with a certain frequency; and generally relating to climate crisis plans.

WHEREAS, There is definitive evidence indicating that human activity has increased the level of greenhouse gases in Earth's atmosphere that contribute significantly to climate change; and

WHEREAS, Climate change, if left unchecked, will have detrimental effects on human health, natural systems, wildlife, and infrastructure that will dramatically increase costs for individuals, communities, businesses, and government; and

WHEREAS, The climate crisis threatens the ability of federal, State, and local government to deliver services, including fire protection, emergency services, flood control, health care, and social services, to populations vulnerable to the effects of climate change; and

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

- 1 WHEREAS, Maryland has 3,190 miles of shoreline that is increasingly being 2 threatened by sea level rise caused by the climate crisis; and 3 WHEREAS, Maryland has billions of dollars of real estate at risk due to sea level 4 rise: and 5 WHEREAS, Scientific consensus demands that the increase in global temperature 6 be limited to not more than 1.5 degrees Celsius to mitigate the most destructive and 7 dangerous effects of climate change; and 8 WHEREAS, The time to take action to reduce climate change is now; now, therefore, 9 SECTION 1.
