19 20	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

23	(e) (2) As a condition of licensure, each hospital shall:

- 1 Establish a credentialing process for the physicians who are (i) 2 employed by or who have staff privileges at the hospital; and 3 (ii) Use the uniform standard credentialing form as the initial application of a physician seeking to be credentialed. 4 5 The Secretary shall, by regulation and in consultation with hospitals, physicians, interested community and advocacy groups, and representatives of 6 7 the Maryland Defense Bar and Plaintiffs' Bar, establish minimum standards for a 8 credentialing process which shall include: 9 [(i)]A formal written appointment process documenting the 10 physician's education, clinical expertise, licensure history, insurance history, medical history, claims history, and professional experience[.]; 11 12 [(ii)] **2.** A requirement that an initial appointment to staff not be complete until the physician has successfully completed a probationary period[.]; AND 13 14 [(iii)] **3.** [A] SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, A formal, written reappointment process to be conducted [at least every 2] 15 vears] IN ACCORDANCE WITH STANDARDS OF THE ACCREDITATION BODY THAT 16 17 ACCREDITS A HOSPITAL. 18 (II)The reappointment **ESTABLISHED** UNDER process 19 SUBPARAGRAPH (I)3 OF THIS PARAGRAPH shall document the physician's pattern of 20 performance by analyzing: 21 Claims filed against the physician; 1. 2. 22 Data dealing with utilization, quality, and risk; 233. Clinical skills; 244. Adherence to hospital bylaws, policies, and procedures; 25 5. Compliance with continuing education requirements; 26 6. Mental and physical status; and 27 7. The results of the practitioner performance evaluation 28 process under subsection (i) of this section.
- 29 (7) If a hospital fails to establish or maintain a credentialing process 30 required under this subsection, the Secretary may impose the following penalties:
 - (i) Delicensure of the hospital; or

- 1 (ii) \$500 per day for each day the violation continues.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 3 October 1, 2023.
