Maryland Higher Education Commission – Access to Mental Health Advisory Committee – Establishment

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 2 That the Laws of Maryland read as follows:

- 15 (5) THE EXECUTIVE DIRECTOR OF THE MARYLAND ASSOCIATION OF
- 16 COMMUNITY COLLEGES, OR THE EXECUTIVE DIRECTOR'S DESIGNEE;
- 17 (6) THE PRESIDENT OF THE MARYLAND INDEPENDENT COLLEGE
- 18 AND UNIVERSITY ASSOCIATION, OR THE PRESIDENT'S DESIGNEE;
- 19 (7) A DIRECTOR OF A CAMPUS-BASED MENTAL HEALTH COUNSELING
- 20 CENTER, APPOINTED BY THE SECRETARY;
- 21 (8) A CAMPUS-BASED CLINICAL PSYCHOLOGIST, APPOINTED BY THE
- 22 SECRETARY;
- 23 (9) TWO LICENSED CLINICAL SOCIAL WORKERS WITH CAMPUS-BASED
- 24 CLINICAL EXPERIENCE, APPOINTED BY THE SECRETARY;
- 25 (10) Two behavioral health counselors from a community
- 26 COLLEGE, APPOINTED BY THE EXECUTIVE DIRECTOR OF THE MARYLAND
- 27 ASSOCIATION OF COMMUNITY COLLEGES; AND
- 28 (11) A BEHAVIORAL HEALTH COUNSELOR FROM A NONPUBLIC
- 29 INSTITUTION OF HIGHER EDUCATION IN THE STATE, APPOINTED BY THE

- 1 PRESIDENT OF THE MARYLAND INDEPENDENT COLLEGE AND UNIVERSITY
- 2 ASSOCIATION;
- 3 (12) Two University System of Maryland Student
- 4 REPRESENTATIVES:
- 5 (I) ONE STUDENT WHO IS A MEMBER OF A MENTAL HEALTH
- 6 ADVOCACY GROUP; AND
- 7 (II) ONE STUDENT WHO HAS ACCESSED, OR IS ELIGIBLE TO
- 8 ACCESS, MENTAL HEALTH SERVICES AT THE INSTITUTION; AND
- 9 (13) ONE STUDENT REPRESENTATIVE ENROLLED IN ST. MARY'S
- 10 COLLEGE OF MARYLAND, MORGAN STATE UNIVERSITY, A COMMUNITY COLLEGE, OR
- 11 A NONPROFIT INSTITUTION OF HIGHER EDUCATION IN THE STATE.
- 12 (C) (1) THE COMMITTEE SHALL ELECT A CHAIR FROM AMONG ITS
- 13 MEMBERS.
- 14 (2) THE COMMITTEE MAY ELECT OTHER OFFICERS AS DETERMINED
- 15 BY THE COMMITTEE.
- 16 (D) THE <del>COMMISSION SHALL PROVIDE</del> STAFF FOR THE COMMITTEE SHALL
- 17 BE PROVIDED ON A ROTATING BASIS BY THE INSTITUTIONS OF HIGHER EDUCATION
- 18 THAT HAVE MEMBERS ON THE COMMITTEE.
- 19 (E) THE COMMITTEE SHALL MEET SIX TIMES PER YEAR.
- 20 **(F)** A MEMBER OF THE COMMITTEE:
- 21 (1) May not receive compensation as a member of the
- 22 COMMITTEE; BUT
- 23 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
- 24 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.
- 25 (G) THE COMMITTEE SHALL:
- 26 (1) STUDY THE POLICIES AND PROCEDURES ADOPTED BY
- 27 INSTITUTIONS OF HIGHER EDUCATION IN THE STATE REGARDING ACCESS TO
- 28 MENTAL HEALTH CARE AND THE PREVENTION AND TREATMENT OF MENTAL
- 29 ILLNESS IN STUDENTS:

- 1 (2) EXAMINE THE CHALLENGES FOR INSTITUTIONS OF HIGHER 2 EDUCATION IN MEETING THE DEMAND FOR MENTAL HEALTH SERVICES;
- 3 (3) REVIEW BEST PRACTICES FOR ACCESSING OFF-CAMPUS MENTAL 4 HEALTH SERVICES;
- 5 (4) REVIEW BEST PRACTICES FOR, AND BARRIERS TO, THE 6 IMPLEMENTATION OF COUNSELING SERVICES, INCLUDING CRISIS, PERSONAL, 7 MENTAL HEALTH, SEXUAL VIOLENCE, AND SUBSTANCE ABUSE COUNSELING;
- 8 (5) REVIEW AND IDENTIFY THE BEST MODELS FOR PROVIDING 9 MENTAL HEALTH SERVICES, INCLUDING STAND-ALONE CENTERS, CENTERS WITH 10 INTEGRATED STUDENT HEALTH SERVICES, COMPREHENSIVE SERVICES, CASE 11 MANAGEMENT, AND CRISIS RESOURCES;
- 12 **(6) I**DENTIFY CONCERNS IN RURAL AREAS AND WORKFORCE 13 **SHORTAGE AREAS**;
- 14 (7) MAKE RECOMMENDATIONS REGARDING:
- 15 (I) WAYS TO REDUCE COSTS AND BARRIERS TO PROVIDING 16 ACCESS TO MENTAL HEALTH SERVICES ON CAMPUS;
- 17 (II) THE USE OF TELEMEDICINE AND VIDEO CONFERENCING IN 18 THE PROVISION OF MENTAL HEALTH SERVICES;
- 19 (III) THE USE OF HOTLINES AND OTHER MEANS TO DISSEMINATE 20 TO STUDENTS INFORMATION RELATED TO MENTAL HEALTH SERVICES ON AND OFF 21 CAMPUS, INCLUDING INFORMATION CONCERNING AVAILABILITY AND FEES; AND
- 22 (IV) THE IMPLEMENTATION OF GENERAL MENTAL HEALTH 23 COUNSELING SERVICES AND SPECIALIZED COUNSELING SERVICES; AND
- 24 (8) STUDY AND MAKE RECOMMENDATIONS REGARDING ANY OTHER 25 MATTERS THE COMMITTEE CONSIDERS APPROPRIATE.
- (H) ON OR BEFORE DECEMBER 1, 2023, AND ON OR BEFORE DECEMBER 1
  27 EACH YEAR THEREAFTER, THE COMMITTEE SHALL REPORT ITS FINDINGS AND
  28 RECOMMENDATIONS TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF
  29 THE STATE GOVERNMENT ARTICLE, THE SENATE BUDGET AND TAXATION
  30 COMMITTEE, THE SENATE EDUCATION, ENERGY, AND THE ENVIRONMENT
  31 COMMITTEE, THE HOUSE WAYS AND MEANS COMMITTEE, AND THE HOUSE
  32 APPROPRIATIONS COMMITTEE.
