13	(a) A sheriff shall give notice of the time, place, and terms of the sale of any
4	property under execution before the property can be sold.
15	(b) In the case of a sale of an interest in property, the notice shall be posted on
6	the courthouse door or on a bulletin board in the immediate vicinity of the door of the
17 18	courthouse and printed in a newspaper, published in the county where the property is located at least:
9	(1) Ten days before the sale of personal property; or
20	(2) 20 days before the sale of real property.
21	(c) If the sheriff gives notice by publication in a newspaper, he may recover the
22	costs of publication from the defendant. If the defendant is unable to pay the costs, the
23	sheriff may recover the costs of publication from the plaintiff.
24	(D) IN ADDITION TO THE NOTICE REQUIREMENT UNDER SUBSECTION (A) OF
25	THIS SECTION, AT LEAST 20 DAYS BEFORE THE SALE OF REAL PROPERTY UNDER
26	EXECUTION, THE JUDGMENT CREDITOR SHALL:

- 7 (E) (1) THE MAILINGS REQUIRED UNDER SUBSECTION (D) OF THIS
  8 SECTION SHALL BE SENT TO THE LAST KNOWN ADDRESS OF EACH PERSON,
  9 INCLUDING TO THE LAST ADDRESS REASONABLY ASCERTAINABLE FROM A
  10 DOCUMENT RECORDED, INDEXED, AND AVAILABLE FOR PUBLIC INSPECTION AT THE

32 (a) In this section, "value" means fair market value as of the date upon which the 33 execution or other judicial process becomes effective against the property of the debtor, or 34 the date of filing the petition under the federal Bankruptcy Code.

- 1 (b) The following items are exempt from execution on a judgment:
- 2 Wearing apparel, books, tools, instruments, or appliances, in an amount 3 not to exceed \$5,000 in value necessary for the practice of any trade or profession except 4 those kept for sale, lease, or barter.
- 5 Except as provided in subsection (i) of this section, money payable in (2)6 the event of sickness, accident, injury, or death of any person, including compensation for loss of future earnings. This exemption includes but is not limited to money payable on account of judgments, arbitrations, compromises, insurance, benefits, compensation, and 8 relief. Disability income benefits are not exempt if the judgment is for necessities contracted for after the disability is incurred. 10
- (3) Professionally prescribed health aids for the debtor or any dependent of 11 12 the debtor.
- 13 The debtor's interest, not to exceed \$1,000 in value, in household **(4)** 14 furnishings, household goods, wearing apparel, appliances, books, animals kept as pets, 15 and other items that are held primarily for the personal, family, or household use of the 16 debtor or any dependent of the debtor.
- 17 Cash or property of any kind equivalent in value to \$6,000 is exempt, if 18 within 30 days from the date of the attachment or the levy by the sheriff, the debtor elects 19 to exempt cash or selected items of property in an amount not to exceed a cumulative value 20 of \$6,000.
- 21(6)Money payable or paid in accordance with an agreement or court order 22for child support.
- 23 (7)Money payable or paid in accordance with an agreement or court order 24for alimony to the same extent that wages are exempt from attachment under § 2515–601.1(b)(1)(ii) or (2)(i) of the Commercial Law Article.
- 26 The debtor's beneficial interest in any trust property that is immune 27 from the claims of the debtor's creditors under § 14.5–511 of the Estates and Trusts Article.
- 28 With respect to claims by a separate creditor of a husband or wife, trust 29 property that is immune from the claims of the separate creditors of the husband or wife under § 14.5–511 of the Estates and Trusts Article. 30
- 31 [In] EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, IN order to determine whether the property listed in subsection (b)(4) and 32 33 (5) of this section is subject to execution, the sheriff shall appraise the property at the time 34 of levy.
