THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY, 1 **(2)** 2 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND. - (J) MONEY EXPENDED FROM THE FUND FOR THE OUTREACH, TRAINING, EDUCATION, AND GRANTS UNDER SUBSECTION (G) OF THIS SECTION IS SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT OTHERWISE WOULD BE APPROPRIATED FOR FORESTRY EDUCATION AND OUTREACH.
- 29 (K) FOR FISCAL YEAR 2025 AND EACH FISCAL YEAR THEREAFTER, THE 30 GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$250,000 TO THE FUND.
