- 7 (4) recommend an initial allocation to the Behavioral Health Workforce 8 Investment Fund established under § 10–1602 of the Health – General Article, as enacted 9 by Section 1 of this Act, and identify specifically which programs the allocation will support 10 and the number of professionals and paraprofessionals the allocation will train, certify, 11 recruit, and place.
