CHAPTER _____

1 AN ACT concerning

2 **Criminal Law – Victims of Child Sex Trafficking and Human Trafficking – Safe**
3 **Harbor and Service Response**

4 FOR the purpose of altering procedures that a law enforcement officer and a court are
5 required to follow when the law enforcement officer or court has reason to believe
6 that a child who has been detained is a victim of sex trafficking or a victim of human
7 trafficking; providing that a minor may not be criminally prosecuted or proceeded
8 against under certain provisions of law for a certain offense if the minor committed
9 the offense as a direct result of being a victim of sex trafficking or being a victim of
10 human trafficking; altering the list of offenses for which a person may file a motion
11 to vacate judgment if the person’s participation was a result of being a victim of
12 human trafficking; and generally relating to victims of child sex trafficking and
13 human trafficking.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 27 That the Laws of Maryland read as follows:

28 **Article – Courts and Judicial Proceedings**

29 3–8A–01.

30 (a) In this subtitle the following words have the meanings indicated, unless the
 31 context of their use indicates otherwise.

32 (dd) “Violation” means a violation for which a citation is issued under:

33 (1) § 5–601 of the Criminal Law Article involving the use or possession of
 34 cannabis;

35 (2) § 10–113, § 10–114, § 10–115, or § 10–116 of the Criminal Law Article;

1 (3) § 10–132 of the Criminal Law Article;

2 (4) § 10–136 of the Criminal Law Article; or

3 (5) § 26–103 of the Education Article.

4 3–8A–14.

5 (a) A child may be taken into custody under this subtitle by any of the following
6 methods:

7 (1) Pursuant to an order of the court;

8 (2) By a law enforcement officer pursuant to the law of arrest;

9 (3) By a law enforcement officer or other person authorized by the court if
10 the officer or other person has reasonable grounds to believe that the child is in immediate
11 danger from the child's surroundings and that the child's removal is necessary for the
12 child's protection;

13 (4) By a law enforcement officer or other person authorized by the court if
14 the officer or other person has reasonable grounds to believe that the child has run away
15 from the child's parents, guardian, or legal custodian; or

16 (5) In accordance with § 3–8A–14.1 of this subtitle.

17 (b) (1) (i) If a law enforcement officer takes a child into custody, the officer
18 shall immediately notify, or cause to be notified, the child's parents, guardian, or custodian
19 in a manner reasonably calculated to give actual notice of the action.

20 (ii) The notice required under subparagraph (i) of this paragraph
21 shall:

22 1. Include the child's location;

23 2. Provide the reason for the child being taken into custody;
24 and

25 3. Instruct the parent, guardian, or custodian on how to
26 make immediate in-person contact with the child.

27 (2) After making every reasonable effort to give actual notice to a child's
28 parent, guardian, or custodian, the law enforcement officer shall with all reasonable speed:

29 (i) Release the child to the child's parents, guardian, or custodian or
30 to any other person designated by the court, upon their written promise to bring the child

1 before the court when requested by the court, and such security for the child's appearance
2 as the court may reasonably require, unless the child's placement in detention or shelter
3 care is permitted and appears required by § 3-8A-15 of this subtitle; or

4 (ii) Deliver the child to the court or a place of detention or shelter
5 care designated by the court.

6 (c) If a parent, guardian, or custodian fails to bring the child before the court
7 when requested, the court may:

8 (1) Issue a writ of attachment directing that the child be taken into custody
9 and brought before the court; and

10 (2) Proceed against the parent, guardian, or custodian for contempt.

11 (d) **(1) (I) IN THIS SUBSECTION THE FOLLOWING WORDS HAVE THE**

13 **(II) "QUALIFYING OFFENSE" HAS THE MEANING STATED IN §**
14 **8-302 OF THE CRIMINAL PROCEDURE ARTICLE.**

15 **(III) "SEX TRAFFICKING" HAS THE MEANING STATED IN § 5-701**
16 **OF THE FAMILY LAW ARTICLE.**

17 **(IV) "VICTIM OF HUMAN TRAFFICKING" HAS THE MEANING**
18 **STATED IN § 8-302 OF THE CRIMINAL PROCEDURE ARTICLE.**

19 **(2)** In addition to the requirements for reporting child abuse and neglect
20 under § 5-704 of the Family Law Article, if a law enforcement officer has reason to believe
21 that a child who has been detained is a victim of sex trafficking[, as defined in § 5-701 of
22 the Family Law Article] **OR A VICTIM OF HUMAN TRAFFICKING**, the law
23 enforcement officer shall [notify any], **AS SOON AS PRACTICABLE:**

24 **(I) NOTIFY AN** appropriate regional navigator, as defined in §
25 5-704.4 of the Family Law Article, for the jurisdiction where the child was taken into
26 custody or where the child is a resident that the child is a suspected victim of sex trafficking
27 **OR A SUSPECTED VICTIM OF HUMAN TRAFFICKING SO THE REGIONAL NAVIGATOR**
28 **CAN COORDINATE A SERVICE RESPONSE;**

29 **(II) REPORT TO THE LOCAL CHILD WELFARE AGENCY THAT THE**
30 **CHILD IS A SUSPECTED VICTIM OF SEX TRAFFICKING OR A SUSPECTED VICTIM OF**
31 **HUMAN TRAFFICKING; AND**

32 **(III) RELEASE THE CHILD TO THE CHILD'S PARENTS, GUARDIAN,**
33 **OR CUSTODIAN IF IT IS SAFE AND APPROPRIATE TO DO SO, OR TO THE LOCAL CHILD**

1 WELFARE AGENCY IF THERE IS REASON TO BELIEVE THAT THE CHILD'S SAFETY WILL
2 BE AT RISK IF THE CHILD IS RETURNED TO THE CHILD'S PARENTS, GUARDIAN, OR
3 CUSTODIAN.

4 (3) A LAW ENFORCEMENT OFFICER WHO TAKES A CHILD WHO IS A
5 SUSPECTED VICTIM OF SEX TRAFFICKING OR A SUSPECTED VICTIM OF HUMAN
6 TRAFFICKING INTO CUSTODY UNDER SUBSECTION (A)(3) OF THIS SECTION MAY NOT
7 DETAIN THE CHILD IN A JUVENILE DETENTION FACILITY, AS DEFINED UNDER §
8 9-237 OF THE HUMAN SERVICES ARTICLE, IF THE REASON FOR DETAINING THE
9 CHILD IS A SUSPECTED COMMISSION OF A QUALIFYING OFFENSE OR § 3-1102 OF
10 THE CRIMINAL LAW ARTICLE.

11 (e) The Supreme Court of Maryland may adopt rules concerning
12 age-appropriate language to be used to advise a child who is taken into custody of the
13 child's rights.

25 (B) (1) AT ANY TIME AFTER A PETITION ALLEGING THAT A CHILD HAS
26 COMMITTED A QUALIFYING OFFENSE, A VIOLATION, OR AN OFFENSE UNDER §
27 3-1102 OF THE CRIMINAL LAW ARTICLE IS FILED WITH THE COURT UNDER THIS
28 SUBTITLE, THE COURT ON ITS OWN MOTION, OR ON MOTION OF THE CHILD'S
29 COUNSEL OR THE STATE'S ATTORNEY, SHALL:

30 (I) MAKE THE DETERMINATION REQUIRED UNDER
31 PARAGRAPH (3) OF THIS SUBSECTION;

32 (II) STAY ALL PROCEEDINGS UNTIL THE DETERMINATION IS
33 MADE; AND

1 (III) REFER THE CHILD TO A REGIONAL NAVIGATOR AND NOTIFY
2 THE DEPARTMENT OF HUMAN SERVICES.

3 (2) THE COURT:

4 (I) SHALL SCHEDULE A HEARING WITHIN 15 DAYS AFTER A
5 MOTION IS FILED UNDER PARAGRAPH (1) OF THIS SUBSECTION; AND

6 (II) MAY, ON GOOD CAUSE SHOWN, EXTEND THE TIME FOR THE
7 HEARING AN ADDITIONAL 15 DAYS.

8 (3) THE COURT SHALL DETERMINE, BY EVIDENCE PRESENTED ON
9 THE RECORD AND BY A PREPONDERANCE OF THE EVIDENCE, WHETHER THE CHILD:

10 (I) IS A VICTIM OF SEX TRAFFICKING OR A VICTIM OF HUMAN
11 TRAFFICKING; AND

12 (II) COMMITTED THE QUALIFYING OFFENSE, VIOLATION, OR
13 OFFENSE UNDER § 3-1102 OF THE CRIMINAL LAW ARTICLE AS A DIRECT RESULT OF
14 BEING A VICTIM OF SEX TRAFFICKING OR BEING A VICTIM OF HUMAN TRAFFICKING.

15 (4) THE COURT SHALL DISMISS THE ~~CASE~~ CHARGE FOR ANY
16 QUALIFYING OFFENSE, VIOLATION, OR OFFENSE UNDER § 3-1102 OF THE CRIMINAL
17 LAW ARTICLE IF THE COURT FINDS THAT THE CHILD:

18 (I) IS A VICTIM OF SEX TRAFFICKING OR A VICTIM OF HUMAN
19 TRAFFICKING; AND

20 (II) COMMITTED THE QUALIFYING OFFENSE, VIOLATION, OR
21 OFFENSE UNDER § 3-1102 OF THE CRIMINAL LAW ARTICLE AS A DIRECT RESULT OF
22 BEING A VICTIM OF SEX TRAFFICKING OR BEING A VICTIM OF HUMAN TRAFFICKING.

1 (XXVI) SOLICITING OR OFFERING TO SOLICIT PROSTITUTION
2 OR ASSIGNATION UNDER § 11-306 OF THE CRIMINAL LAW ARTICLE.

3 (3) "Victim of human trafficking" means a person who has been subjected
4 to an act of another committed in violation of:

5 (i) Title 3, Subtitle 11 of the Criminal Law Article; or

6 (ii) § 1589, § 1590, § 1591, or § 1594(a) of Title 18 of the United States
7 Code.

8 (b) A person convicted of a qualifying offense may file a motion to vacate the
9 judgment if the person's participation in the offense was a direct result of being a victim of
10 human trafficking.

14 following words have the meanings indicated.

15 (x) "Sex trafficking" means the recruitment, harboring, transportation, provision,
16 obtaining, patronizing, or soliciting of a child for the purpose of a commercial sex act.
