BY adding to Chapter 99 – Charter of the Town of Mount Airy Section A1–101 through A1–114 to be under the new heading "Appendix I – Urban Renewal Authority for Slum Clearance" Public Local Laws of Maryland – Compilation of Municipal Charters (2014 Replacement Edition, Revisions Current as of November 2021) SECTION 1.
