- FOR the purpose of altering requirements for members of the Washington County Board of Electrical Examiners and Supervisors; altering requirements for the examination and licensing of Restricted Electricians in the county; requiring Master Electricians to be registered by the county instead of licensed by the county; altering the Washington County Department of Permits and Inspections to be the Washington County Division of Permits and Inspections; and generally relating to electrician licensure and registration in Washington County.

- 26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 3 (b) (5) (i) For any fiscal year, this paragraph applies to the development of
- 4 a single subdivision where the Washington County [Department] **DIVISION** of Permits and
- 5 Inspections has issued more than 25 building permits for new residential units in that fiscal
- 6 year.

- 8 (a) In this subtitle, "Board" means the Board of Electrical Examiners and 9 Supervisors.
- 10 (b) The County Commissioners shall appoint a Board of Electrical Examiners and Supervisors, consisting of 5 individuals, for the purpose of examining into the qualifications
- 12 and capabilities of all individuals who are engaged or desire to engage in the business of
- 13 Master Electrician as defined in this subtitle.
- 14 (c) The Board shall consist of 4 competent individuals who are familiar with the
- 15 electrical business. Those individuals shall [have been] BE residents of the county [for at
- 16 least 5 years]. One individual shall be selected from an electric public utility company doing
- 17 business in Washington County, 2 individuals shall be from among the [duly licensed]
- 18 REGISTERED Master Electricians in the county, and 1 member shall be appointed
- 19 at-large. Their term of office shall be for 2 years.
- 20 (d) The fifth member shall be designated by the Washington County Fire and
- 21 Rescue Association and shall be an active member of a Volunteer Fire Company in the
- 22 county. The term of office of this member is 2 years.
- 23 (e) Should a vacancy occur during the term of any member, the County
- 24 Commissioners shall appoint an individual to fill the vacant position. The County
- 25 Commissioners may remove any member of the Board for incompetency or improper
- 26 conduct upon satisfactory evidence being presented to it of the condition.

- (a) (1) In this subtitle, Master Electrician means and includes any and all individuals engaged in the business of, or holding themselves out to the public as engaged in the business of installing, erecting, or repairing, or contracting to install, erect, or repair electric wires or conductors that are used for the transmission of electric current for electric light, heat, or power purposes, or moldings, ducts, raceways, or conduits for the reception or protection of such wires or conductors, or to any electrical machinery, apparatus, devices, or fixtures to be used for electric light, heat, or power purposes.
- 9 (2) In this subtitle, "Restricted Electrician" means any individual who has 10 been found competent by the Board of Electrical Examiners and Supervisors to engage in 11 limited fields of electrical work.
- 12 (b) (1) A "Master Electrician" [license] REGISTRATION issued in accordance 13 with the provisions of this subtitle and the rules and regulations of the Board entitles any 14 [licensed] REGISTERED individual to engage in the business of and to hold himself out to 15 the public as engaged in the business of installing, erecting, and repairing and of 16 contracting to install, erect, and repair any electric wires or conductors, etc.
 - (2) A "Restricted Electrician" license issued in accordance with this subtitle and the rules and regulations of the Board permits any licensed individual to engage in the business of and to hold himself or herself out to the public as engaged in the business of installation and repair of the particular category of electrical equipment and apparatus described in the rules and regulations of the Board and on the license.
- 22 (c) This subtitle does not apply to any firm or corporation if the individual 23 managing and in charge of the electrical work for the firm or corporation is a Master 24 Electrician [licensed] REGISTERED under this subtitle.

- 26 (a) Before any individual engages in the business of a [Master Electrician or]
 27 Restricted Electrician in Washington County, that individual shall apply to the Board for
 28 a license examination OR RECIPROCATE FROM THE ORIGINAL JURISDICTION WHERE
 29 THE EXAMINATION WAS ADMINISTERED.
- 30 (b) The Board shall hold license examinations 4 times annually at a time and 31 place determined by the Board.
- 32 (c) Examinations shall be administered and results determined according to the 33 rules and regulations of the Board.

- 1 (a) (1) Before the issuance or the renewal of a Master Electrician's [license]
 2 **REGISTRATION** or a Restricted Electrician's license, an individual shall deliver to the
 3 Board a certificate of comprehensive general liability insurance, including completed
 4 operations coverage, with limits of \$300,000 for bodily injury and \$100,000 for property
 5 damage.
- 6 (2) The certificate of insurance shall be issued to the "Board of Electrical Examiners and Supervisors of Washington County" with the applicant's name, and 8 company name if applicable, appearing on the certificate.
- 9 (3) A holder of a Master Electrician's [license] **REGISTRATION** shall 10 forward any notice of cancellation of insurance to the Board within 10 days of the 11 cancellation date.
- 12 (4) Insurance obtained in compliance with this section shall relieve the 13 applicant for a Master Electrician's [license] **REGISTRATION** from any requirement to 14 furnish a separate surety bond.
- 15 (5) An applicant for a Restricted Electrician's license shall also comply with the insurance requirements of this section.
- 17 (6) Holders of an inactive Master Electrician's [license] **REGISTRATION**18 are exempt from the insurance requirements of this subsection.
- 19 (b) The fees shall be determined by a fee schedule adopted by the County 20 Commissioners.

- The Board may revoke or suspend for proper cause any **REGISTRATION OR** license or **REGISTRATION OR** license renewal after a full hearing of all parties in interest.

- This subtitle may not be construed to prevent any individual from doing or performing any of the kinds of work enumerated in this subtitle if that work is performed under the direction and supervision of a [duly licensed] REGISTERED Master Electrician. The [licensed] REGISTERED Master Electrician shall be responsible for any and all work done under the authority granted by the Master Electrician's [license] REGISTRATION. Any person working under the authority of a Master Electrician's [license] REGISTRATION shall work under the direct supervision of the [licensed] REGISTERED Master Electrician.

(a) A person is guilty of a misdemeanor who:

- 1 (1) Practices, engages, or continues in the work of a Master Electrician or 2 a Restricted Electrician without compliance with all the provisions of this subtitle;
- 3 (2) Performs the work of a Master Electrician or a Restricted Electrician 4 while not **REGISTERED OR** licensed as, or under the supervision of, a Master Electrician 5 or a Restricted Electrician, respectively;
- 6 (3) Has been [licensed] **REGISTERED** as a Master Electrician or 7 **LICENSED AS** a Restricted Electrician and who fails to renew his **REGISTRATION OR** 8 license and performs the work of a Master Electrician or a Restricted Electrician; and
- 9 (4) Violates any of the provisions of this subtitle.
- 10 (b) (1) Upon conviction, the person shall be fined not less than \$250 nor more 11 than \$1,000 or imprisoned not more than 90 days, or both.
- 12 (2) Any conviction automatically shall revoke and annul any license that 13 may have been issued to that person.

- 15 (a) A **REGISTRATION OR** license or **REGISTRATION OR** license renewal granted 16 or issued under the provisions of this subtitle shall specify:
- 17 (1) The name of the individual to whom it is issued; or
- 18 (2) If the Board has authorized the assignment of the license **OR**19 **REGISTRATION** or license **OR REGISTRATION** renewal, the name of the individual to whom it is assigned.
- 21 (b) An unlicensed individual, firm, or corporation may not obtain a permit to 22 perform electrical work under the authority of a licensee.

- All fees collected under the provisions of this subtitle shall be collected by the Washington County [Department] **DIVISION** of Permits and Inspections.

- 27 (a) An electric light or power company may not attach its power lines or electric 28 meters to any consumer's property within the borders of Washington County unless and 29 until a temporary or permanent meter cut—in certificate has been issued by the Washington 30 County [Department] **DIVISION** of Permits and Inspections.

SENATE BILL 326

- 1 (b) The Washington County [Department] **DIVISION** of Permits and Inspections 2 shall issue a meter cut—in card to the power or electric company furnishing the electricity 3 to the consumer's property.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 October 1, 2023.
