## A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Casting General Election Ballot in Multiple States – Prohibition**

3 FOR the purpose of prohibiting a person from willfully or knowingly casting a ballot in a  
4 general election in more than one state in the same year; and generally relating to  
5 election law violations related to voting.

6 BY repealing and reenacting, with amendments,  
7 Article – Election Law

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

### Article – Election Law

14 16–201.

15 (a) A person may not willfully and knowingly:

16 (1) (i) impersonate another person in order to vote or attempt to vote;  
17 or

18 (ii) vote or attempt to vote under a false name;

19 (2) vote more than once for a candidate for the same office or for the same  
20 ballot question;

21 (3) vote or attempt to vote more than once in the same election, or vote in  
22 more than one election district or precinct;

1           (4)    **CAST A BALLOT IN A GENERAL ELECTION IN MORE THAN ONE**  
2 **STATE IN THE SAME YEAR;**

3           **(5)**    vote in an election district or precinct without the legal authority to vote  
4 in that election district or precinct;

5           **[(5)] (6)**    influence or attempt to influence a voter's voting decision  
6 through the use of force, threat, menace, intimidation, bribery, reward, or offer of reward;

7           **[(6)] (7)**    influence or attempt to influence a voter's decision whether to go  
8 to the polls to cast a vote through the use of force, fraud, threat, menace, intimidation,  
9 bribery, reward, or offer of reward; or

10          **[(7)] (8)**    engage in conduct that results or has the intent to result in the  
11 denial or abridgement of the right of any citizen of the United States to vote on account of  
12 race, color, or disability.

13          (b)    Except as provided in § 16–1002 of this title, a person who violates this section  
14 is guilty of a misdemeanor and on conviction is subject to a fine of not more than \$5,000 or  
15 imprisonment for not more than 5 years or both.

16          (c)    A person who violates this section is subject to § 5–106(b) of the Courts Article.

17          SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 October 1, 2023.
