A BILL ENTITLED

1 AN ACT concerning

2 **Income Tax – Subtraction Modification – Water Affordability Assistance**

3 FOR the purpose of allowing a subtraction modification under the Maryland income tax for
4 certain water affordability assistance received by an individual during the taxable
5 year and provided by the federal government, the State, or a local government; and
6 generally relating to a subtraction modification under the Maryland income tax for
7 water affordability assistance.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Tax – General**

21 10–207.

22 (a) To the extent included in federal adjusted gross income, the amounts under
23 this section are subtracted from the federal adjusted gross income of a resident to determine
24 Maryland adjusted gross income.

1 **(OO) (1) THE SUBTRACTION UNDER SUBSECTION (A) OF THIS SECTION**
2 **INCLUDES THE AMOUNT OF WATER AFFORDABILITY ASSISTANCE, INCLUDING**
3 **WATER BILL ARREARAGE FORGIVENESS, RECEIVED BY AN INDIVIDUAL DURING THE**
4 **TAXABLE YEAR AND PROVIDED BY THE FEDERAL GOVERNMENT, THE STATE, OR A**
5 **LOCAL GOVERNMENT.**

6 **(2) ON REQUEST, A UNIT OF STATE GOVERNMENT OR A LOCAL**
7 **GOVERNMENT THAT ADMINISTERS A WATER AFFORDABILITY ASSISTANCE PROGRAM**
8 **SHALL PROVIDE TO THE COMPTROLLER, WITHIN 30 DAYS OF THE DATE OF THE**
9 **REQUEST AND IN THE MANNER REQUESTED BY THE COMPTROLLER, THE**
10 **FOLLOWING INFORMATION:**

11 **(I) THE NAMES OF WATER AFFORDABILITY ASSISTANCE**
12 **PROGRAMS ADMINISTERED BY THE UNIT OR LOCAL GOVERNMENT;**

13 **(II) A LIST OF RECIPIENTS OF WATER AFFORDABILITY**
14 **ASSISTANCE, INCLUDING THE NAME, ADDRESS, AND TAX IDENTIFICATION NUMBER**
15 **OF EACH RECIPIENT;**

16 **(III) THE AMOUNT OF WATER AFFORDABILITY ASSISTANCE**
17 **PROVIDED TO THE INDIVIDUAL;**

18 **(IV) THE DATE THAT THE WATER AFFORDABILITY ASSISTANCE**
19 **WAS PROVIDED TO THE PERSON; AND**

20 **(V) ANY OTHER INFORMATION REQUESTED REGARDING THE**
21 **WATER AFFORDABILITY ASSISTANCE.**

22 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**
23 **1, 2023, and shall be applicable to all taxable years beginning after December 31, 2022.**
