1 The Governor shall designate the chair of the Task Force. (c) 2 The Maryland Department of Health shall provide staff for the Task Force. (d) A member of the Task Force: 3 (e) may not receive compensation as a member of the Task Force; but 4 (1) 5 (2)is entitled to reimbursement for expenses under the Standard State 6 Travel Regulations, as provided in the State budget. 7 The Task Force shall: (f) 8 identify potential solutions to reduce excessive wait times in emergency (1) 9 departments in the State; 10 (2)study best practices for emergency department staffing, triage, and bed availability in states that: 11 12 (i) have a population similar to Maryland; 13 have at least one city of approximately 500,000 residents; and (ii) 14 (iii) rank within the top 50% of states in shortest emergency room 15 wait time; and 16 (3)make recommendations regarding best practices for reducing 17 emergency department wait times that should be implemented in the State. 18 (g) On or before January 1, 2024, the Task Force shall report its findings and 19 recommendations to the Governor and, in accordance with § 2-1257 of the State 20 Government Article, the General Assembly. 21SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2023. It shall remain effective for a period of 1 year and 1 month and, at the end of June 22 2330, 2024, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect. 24
