## A BILL ENTITLED

1 AN ACT concerning

2 **Provision of Veterinary Services – Routine Medical Care and Rabies Vaccines**

3 FOR the purpose of requiring the State Board of Veterinary Medical Examiners to  
4 authorize a certain veterinary practitioner licensed to practice veterinary medicine  
5 in another state or jurisdiction to provide routine medical care in the State under  
6 certain circumstances; requiring the Secretary of Health to allow individuals who  
7 work in or for a certain veterinary hospital or a certain animal control facility to  
8 administer rabies vaccines under certain circumstances; and generally relating to  
9 the provision of veterinary services in the State.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
4 That the Laws of Maryland read as follows:

5 **Article – Agriculture**

6 2–304.

7 [(e) (1) The Board may authorize the practice of a health occupation on an  
8 animal by a health care practitioner licensed, certified, or otherwise authorized under the  
9 Health Occupations Article.

10 (2) If the Board authorizes the practice of a health occupation on an animal  
11 under paragraph (1) of this subsection, the Board may:

12 (i) Impose requirements for education, training, and supervision by  
13 a veterinary practitioner; and

14 (ii) Require the registration of each health care practitioner  
15 authorized to practice a health occupation on an animal in accordance with this subsection.]

16 [(f) (E) On or before December 31 each year, the Board shall report to the  
17 Governor and, in accordance with § 2–1257 of the State Government Article, the General  
18 Assembly on the Board’s disciplinary activities for the previous fiscal year.

19 **2–305.1.**

20 **(A) (1) THE BOARD MAY AUTHORIZE THE PRACTICE OF A HEALTH**  
21 **OCCUPATION ON AN ANIMAL BY A HEALTH CARE PRACTITIONER LICENSED,**  
22 **CERTIFIED, OR OTHERWISE AUTHORIZED UNDER THE HEALTH OCCUPATIONS**  
23 **ARTICLE.**

24 **(2) IF THE BOARD AUTHORIZES THE PRACTICE OF A HEALTH**  
25 **OCCUPATION ON AN ANIMAL UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE**  
26 **BOARD MAY:**

27 **(I) IMPOSE REQUIREMENTS FOR EDUCATION, TRAINING, AND**  
28 **SUPERVISION BY A VETERINARY PRACTITIONER; AND**

29 **(II) REQUIRE THE REGISTRATION OF EACH HEALTH CARE**  
30 **PRACTITIONER AUTHORIZED TO PRACTICE A HEALTH OCCUPATION ON AN ANIMAL**  
31 **IN ACCORDANCE WITH THIS SUBSECTION.**

1           **(B) (1) THE BOARD SHALL AUTHORIZE A VETERINARY PRACTITIONER**  
2 **LICENSED, CERTIFIED, OR OTHERWISE AUTHORIZED TO PRACTICE VETERINARY**  
3 **MEDICINE IN ANOTHER STATE OR JURISDICTION TO PROVIDE ROUTINE MEDICAL**  
4 **CARE IN THE STATE IF THE VETERINARY PRACTITIONER:**

5                   **(I) WILL PROVIDE THE SERVICES TO AN ANIMAL SHELTER, AS**  
6 **DEFINED IN § 2-1701 OF THIS TITLE, LOCATED IN THE STATE; AND**

7                   **(II) IS NOT OTHERWISE PROHIBITED FROM PRACTICING**  
8 **VETERINARY MEDICINE DUE TO A KNOWN ETHICS OR CRIMINAL VIOLATION.**

9           **(2) THE ROUTINE MEDICAL CARE PROVIDED BY A VETERINARY**  
10 **PRACTITIONER AUTHORIZED TO PRACTICE VETERINARY MEDICINE UNDER**  
11 **PARAGRAPH (1) OF THIS SUBSECTION MAY INCLUDE:**

12                   **(I) SPAYING AND NEUTERING;**

13                   **(II) VACCINATIONS;**

14                   **(III) HEALTH EXAMINATIONS; AND**

15                   **(IV) COMPLETING CERTIFICATIONS OF HEALTH.**

16                                   **Article – Health – General**

17 18-313.

18           The Secretary of Health shall provide a statewide system:

19                   (1) To control rabies;

20                   (2) To grant authority to the public health veterinarian and the local health  
21 officer in matters pertaining to the disposition of animals that bite or otherwise expose  
22 rabies to an individual;

23                   (3) To assist local political subdivisions regarding the laboratory testing of  
24 rabid animals;

25                   (4) To treat each individual who is exposed or suspected of having been  
26 exposed to rabies; [and]

27                   (5) To distribute, in accordance with the conditions set by the Secretary of  
28 Agriculture, the biological products that are needed to prevent and treat rabies; AND

1           **(6) TO ALLOW INDIVIDUALS WHO WORK IN OR FOR A VETERINARY**  
2 **HOSPITAL, AS DEFINED IN § 2-304.1 OF THE AGRICULTURE ARTICLE, OR AN ANIMAL**  
3 **CONTROL FACILITY, AS DEFINED IN § 2-305 OF THE AGRICULTURE ARTICLE, TO**  
4 **ADMINISTER RABIES VACCINES IF:**

5           **(I) FOR AN INDIVIDUAL WORKING IN OR FOR A VETERINARY**  
6 **HOSPITAL, THE VETERINARY HOSPITAL IS LICENSED UNDER § 2-304.1 OF THE**  
7 **AGRICULTURE ARTICLE;**

8           **(II) FOR AN INDIVIDUAL WORKING IN OR FOR AN ANIMAL**  
9 **CONTROL FACILITY, THE ANIMAL CONTROL FACILITY IS LICENSED TO ADMINISTER**  
10 **DRUGS UNDER § 2-305 OF THE AGRICULTURE ARTICLE; AND**

11           **(III) THE RABIES VACCINE IS ADMINISTERED IN ACCORDANCE**  
12 **WITH APPLICABLE PROTOCOLS FOR LICENSED VETERINARIANS.**

13           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2023.
