## A BILL ENTITLED

1 AN ACT concerning

### 2 Provision of Veterinary Services – Routine Medical Care and Rabies Vaccines

- FOR the purpose of requiring the State Board of Veterinary Medical Examiners to authorize a certain veterinary practitioner licensed to practice veterinary medicine in another state or jurisdiction to provide routine medical care in the State under certain circumstances; requiring the Secretary of Health to allow individuals who work in or for a certain veterinary hospital or a certain animal control facility to administer rabies vaccines under certain circumstances; and generally relating to the provision of veterinary services in the State.

8 (II) FOR AN INDIVIDUAL WORKING IN OR FOR AN ANIMAL 9 CONTROL FACILITY, THE ANIMAL CONTROL FACILITY IS LICENSED TO ADMINISTER 10 DRUGS UNDER § 2–305 OF THE AGRICULTURE ARTICLE; AND

11(III) THE RABIES VACCINE IS ADMINISTERED IN ACCORDANCE12WITH APPLICABLE PROTOCOLS FOR LICENSED VETERINARIANS.
