2 Condominiums – Declarations and Mandatory Insurance Coverage – Alterations

FOR the purpose of exempting certain condominium units from a requirement to include certain information in a declaration; altering the types of elements and units for which a council of unit owners is required to maintain certain property insurance and altering certain requirements for the property insurance policy; and generally relating to mandatory insurance coverage for condominiums.

4 (2) Comprehensive general liability insurance, including medical 5 payments insurance, in an amount determined by the council of unit owners, but not less 6 than any amount specified in the declaration or bylaws, covering occurrences commonly 7 insured against for death, bodily injury, and property damage arising out of or in connection 8 with the use, ownership, or maintenance of the common elements.

9 (b) The council of unit owners shall give notice to all unit owners of the 10 termination of any insurance policy within 10 days of termination. The declaration or 11 bylaws may require the council of unit owners to carry any other insurance, and the council 12 of unit owners in any event may carry any other insurance it deems appropriate to protect 13 the council of unit owners or the unit owners.

14 (c) Insurance policies carried pursuant to subsection (a) of this section shall 15 provide that:

16 (1) For property and casualty losses to the common elements and the units, 17 exclusive of improvements and betterments installed in the units by unit owners other than 18 the developer, **OR FOR DETACHED UNITS, PROPERTY AND CASUALTY LOSSES TO THE** 19 **COMMON ELEMENTS,** each unit owner is an insured person under the policy with respect 20 to liability arising out of his ownership of an undivided interest in the common elements or 21 membership in the council of unit owners;

(2) The insurer waives its right to subrogation under the policy against any
 unit owner of the condominium or members of his household;

(3) An act or omission by any unit owner, unless acting within the scope of
his authority on behalf of the council of unit owners, does not void the policy and is not a
condition to recovery under the policy; and

(4) If, at the time of a loss under the policy, there is other insurance in the
name of a unit owner covering the same property covered by the policy, the policy is primary
insurance not contributing with the other insurance.

30 (d) (1) Any loss FOR ATTACHED OR MULTIFAMILY DWELLING UNITS 31 covered by the property policy under subsection (a)(1) of this section shall be adjusted with 32 the council of unit owners, but the insurance proceeds for that loss shall be payable to any 33 insurance trustee designated for that purpose, or otherwise to the council of unit owners, 34 and not to any mortgagee.

35 (2) The insurance trustee or the council of unit owners shall hold any 36 insurance proceeds in trust for unit owners and lien holders as their interests may appear. 1 (3) Subject to the provisions of subsection (g) of this section, the proceeds 2 shall be disbursed first for the repair or restoration of the damaged common elements and 3 units, and unit owners and lien holders are not entitled to receive payment of any portion 4 of the proceeds unless there is a surplus of proceeds after the common elements and units 5 have been completely repaired or restored, or the condominium is terminated.

6 (e) An insurance policy issued to the council of unit owners does not prevent a 7 unit owner from obtaining insurance for his own benefit.

8 (f) (1) An insurer that has issued an insurance policy under this section shall 9 issue certificates or memoranda of insurance to the council of unit owners and, upon 10 request, to any unit owner, mortgagee, or beneficiary under a deed of trust.

11 (2) An insurer may cancel an insurance policy issued under this section in 12 accordance with § 27–603 of the Insurance Article.

13 (g) (1) [Any] SUBJECT TO THE APPLICABLE COVERAGE SPECIFIED 14 UNDER SUBSECTION (A) OF THIS SECTION, ANY portion of the common elements and the 15 units, exclusive of improvements and betterments installed in the units by unit owners 16 other than the developer, damaged or destroyed shall be repaired or replaced promptly by 17 the council of unit owners unless:

(i) The condominium is terminated;

(ii) Repair or replacement would be illegal under any State or local
 health or safety statute or ordinance; or

(iii) 80 percent of the unit owners, including every owner of a unit or
assigned limited common element which will not be rebuilt, vote not to rebuild.

23 (2) (i) 1. The cost of repair or replacement in excess of insurance 24 proceeds and reserves is a common expense.

25 2. A property insurance deductible is not a cost of repair or 26 replacement in excess of insurance proceeds.

(ii) If the cause of any damage to or destruction of any portion of the
condominium originates from the common elements or an event outside of the condominium
units and common elements, the council of unit owners' property insurance deductible is a
common expense.

(iii) 1. If the cause of any damage to or destruction of any portion of the condominium originates from a unit, the owner of the unit where the cause of the damage or destruction originated is responsible for the council of unit owners' property insurance deductible not to exceed \$10,000.
