## A BILL ENTITLED

1 AN ACT concerning

2 **Correctional Services – Inmate Release**

3 FOR the purpose of requiring the Division of Correction to transport a certain inmate from  
4 a certain correctional facility to a certain county after the inmate is released from a  
5 State correctional facility; requiring the Division of Parole and Probation to  
6 supervise any required probation, parole, or mandatory supervision of a certain  
7 inmate in a certain county after the inmate is released from a State correctional  
8 facility; and generally relating to the release of inmates.

9 BY repealing and reenacting, without amendments,  
10 Article – Correctional Services  
11 Section 1–101(a) and (e)  
12 Annotated Code of Maryland  
13 (2017 Replacement Volume and 2022 Supplement)

14 BY adding to  
15 Article – Correctional Services  
16 Section 9–609.2

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

21 **Article – Correctional Services**

22 1–101.

23 (a) In this article the following words have the meanings indicated.

24 (e) “County” means a county of the State and Baltimore City.

2 **AFTER AN INMATE IS RELEASED FROM CONFINEMENT IN A STATE**  
3 **CORRECTIONAL FACILITY:**

4 **(1) THE DIVISION SHALL TRANSPORT THE INMATE FROM THE**  
5 **CORRECTIONAL FACILITY TO THE COUNTY OF THE INMATE'S ADDRESS THAT WAS**  
6 **RECORDED BY THE CORRECTIONAL FACILITY IN THE OFFENDER CASE**  
7 **MANAGEMENT SYSTEM AT THE TIME THE INMATE ENTERED THE CORRECTIONAL**  
8 **FACILITY; AND**

9 **(2) THE DIVISION OF PAROLE AND PROBATION SHALL SUPERVISE**  
10 **ANY REQUIRED PROBATION, PAROLE, OR MANDATORY SUPERVISION OF THE INMATE**  
11 **IN THE COUNTY OF THE INMATE'S ADDRESS THAT WAS RECORDED BY THE**  
12 **CORRECTIONAL FACILITY IN THE OFFENDER CASE MANAGEMENT SYSTEM AT THE**  
13 **TIME THE INMATE ENTERED THE CORRECTIONAL FACILITY.**

14 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
15 **October 1, 2023.**
