## Procurement – Minority Business Enterprises and Veteran–Owned Small Business Enterprises – Participation Goal Scorecard

- FOR the purpose of requiring the Governor's Office of Small, Minority, and Women Business Affairs to develop a scorecard to evaluate units of State government on the units' performance toward meeting certain participation goals under the Minority Business Enterprise Program and the Veteran–Owned Small Business Enterprise Program; establishing a certain grading scale for the scorecard; requiring grades achieved by each unit to be included in the Office's annual report published each year on the Office's website; and generally relating to minority business enterprise and veteran–owned small business enterprise procurement participation.

- 16 **(3)** "C" GRADE FOR A UNIT THAT ACHIEVES BETWEEN 70% AND 79% 17 OF THE APPLICABLE GOAL; AND
- 18 (4) "FAILING" GRADE FOR A UNIT THAT ACHIEVES BELOW 70% OF
  19 THE APPLICABLE GOAL A GRADING SCALE DEVELOPED BY THE OFFICE AS A
  20 WEIGHTED SYSTEM THAT INCLUDES EACH UNIT'S CONTRIBUTION TOWARD MEETING
  21 THE STATEWIDE:
- 22 (1) MINORITY BUSINESS ENTERPRISE PARTICIPATION GOAL; AND
- 23 <u>VETERAN-OWNED SMALL BUSINESS ENTERPRISE GOAL.</u>
- 24 (C) (1) THE OFFICE SHALL <u>INCLUDE PUBLISH</u> THE GRADES ACHIEVED BY 25 EACH UNIT <del>UNDER THIS SECTION IN THE ANNUAL REPORT SUBMITTED UNDER §</del>
- 26 9-306 OF THIS SUBTITLE. UNDER THIS SECTION EACH YEAR ON THE OFFICE'S

- 28 (2) WITHIN 30 DAYS OF PUBLISHING INFORMATION ON ITS WEBSITE
- 29 IN ACCORDANCE WITH PARAGRAPH (1) OF THIS SUBSECTION, THE OFFICE SHALL
- 30 SUBMIT THE INFORMATION PUBLISHED ON ITS WEBSITE TO THE GENERAL
- 31 ASSEMBLY, IN ACCORDANCE WITH § 2–1257 OF THIS ARTICLE.
